A BILL FOR

*Cities & Towns
 City manager*

An Act to amend sections sixty-six hundred sixteen (6616), sixty-six hundred twenty-three (6623), sixty-six hundred twenty-nine (6629), sixty-six hundred thirty (6630), sixty-six hundred thirty-one (6631), sixty-six hundred thirty-eight (6638), sixty-six hundred fifty-one (6651), sixty-six hundred sixty-nine (6669), sixty-six hundred eighty-three (6683), sixty-six hundred eighty-four (6684), Code, 1935, relating to City Managers and City Councils.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Amend Section sixty-six hundred sixteen (6616),
 2 Code, 1935, by inserting after the word "special" in line ten
 3 (10) the words " , general or city".

1 Sec. 2. Amend Section sixty-six hundred twenty-three (6623),
 2 Code, 1935, by adding after the word "special" in line six (6)
 3 the words " , general or city".

1 Sec. 3. Amend Section sixty-six hundred twenty-nine (6629),
 2 Code, 1935, by adding the following: "Except in cities over
 3 100,000 population the term of members of the Library Board, Water
 4 Works Trustees, Permanent Park Board, Playground Commission, City
 5 Planning Commission, Zoning Commission, Board of Adjustment and
 6 Comfort Station Commission and manner of appointment shall continue

7 as now provided by law”.

1 Sec. 4. Amend Section sixty-six hundred thirty (6630), Code,
2 1935, by adding after the word “advisable” in line eight (8) the
3 following provision: “subject to the provisions of the preceding
4 section and chapter 289 of the Code of Iowa”.

1 Sec. 5. Amend Section sixty-six hundred thirty-one (6631),
2 Code, 1935, by adding after the word “advisable” in line eight
3 (8) the following provision: “, subject to the provisions of chap-
4 ter 289, Code, 1935”

1 Sec. 6. Amend Section sixty-six hundred thirty-eight (6638),
2 Code, 1935, by adding thereto the following provision: “In cities
3 in which voting machines are used, this election shall be con-
4 ducted in the same manner as elections are held with the use of
5 voting machines and under the provisions of chapter 43, Code, 1935.”

1 Sec. 7. Amend Section sixty-six hundred fifty-one (6651),
2 Code, 1935, by inserting the words “except in cities over 100,000”
3 after the word “magistrate” in line five (5), and by adding to the
4 section the following provision: “In cities over 100,000 popula-
5 tion it shall appoint members of the Library Board as provided in
6 chapter 299, Code, 1935, Water Works Trustees as provided in
7 chapter 314, Code, 1935, members of the Park Board as provided
8 in chapter 293-D1, Code, 1935, members of the Playground Commis-
9 sion as provided in Chapter 298, Code, 1935, members of the City
10 Planning Commission as provided in Chapter 294-A, Code, 1935,
11 members of the Zoning Commission and the Board of Adjustment as

12 provided in Chapter 324, Code, 1935, and members of the Comfort
13 Station Commission as provided in chapter 297, Code, 1935.”

1 Sec. 8. Amend Section sixty-six hundred sixty-nine (6669),
2 Code, 1935, as follows:

3 a. Amend subsection five (5) thereof by adding the follow-
4 ing: “And in cities of more than 100,000 population the members
5 of the Library Board, Water Works Trustees, Permanent Park Board,
6 Playground Commission, City Planning Commission, Zoning Commission,
7 Board of Adjustment and Comfort Station Commission”.

8 b. Amend subsection six (6) by adding after the word “contract”
9 in line six (6) the following: “except for the Water Works Trustees,
10 Library Boards, and Permanent Park Boards in cities over 100,000
11 population”.

12 c. Amend subsection seven (7) by adding after the word
13 “provided” in line five (5) the following: “, subject to the
14 provisions of chapter 289, Code, 1935”.

15 d. Amend subsection eight (8) by adding after the word
16 “employ” in line four (4) the following: “, subject to the provi-
17 sions of chapter 289, Code, 1935”.

18 e. Amend subsection nine (9) by inserting after the figures
19 “293” in the last line thereof the following: “, 293-D1 and 314”;
20 further amend by adding after the word “buildings” in line ten
21 (10) “except as herein provided”.

22 f. Amend subsection eleven (1) by adding after the word
23 “town” in line eight (8) “except as otherwise herein provided”.

24 g. Amend subsection twelve (12) by inserting in said sub-
25 section after the figures “313” in line twelve (12) “, and except-
26 ing any city of more than 100,000 population owning Water Works
27 under the provisions of Chapter 314, Code, 1935”

28 h. Amend Subsection thirteen (13) by adding after the word
29 “bathhouses” in line five (5) the words “except in cities
30 operating under chapter 293-D1 and Chapter 298, Code, 1935”

1 Sec. 9. Amend Section sixty-six hundred eighty-three (6683),
2 Code, 1935, by striking from line two (2) the words and figures
3 “chapter 293”, and inserting in lieu thereof “chapters 293 and
4 293-D1,”.

1 Sec. 10. Amend Section sixty-six hundred eighty-four (6684),
2 Code, 1935, by striking from line two (2) the words and figures
3 “chapter 322” and inserting in lieu thereof “chapters 322 and
4 322-F1”.
