A BILL FOR

An Act to amend chapter one hundred sixty-seven (167) and sections three thousand two hundred ninety-two (3292), three thousand two hundred ninety-three (3293), three thousand three hundred (3300), three thousand three hundred thirty-one (3331), three thousand three hundred thirty-two (3332), three thousand three hundred fifty-two (3352), three thousand three hundred fifty-six (3356), three thousand three hundred ninety-five (3395), three thousand three hundred ninety-six (3396), three thousand four hundred six (3406), three thousand four hundred sixty-seven (3467), three thousand four hundred ninety-nine (3499) and three thousand five hundred four (3504), Code, 1935, all relating to the powers and duties of the superintendent of the Glenwood state school, state sanatorium, Woodward state school and colony, Cherokee state hospital, Clarinda state hospital, Independence state hospital, and Mount Pleasant state hospital, and providing for the appointment of a business manager for each of said institutions, and prescribing his powers and duties.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Chapter one hundred sixty-seven (167), Code,
- 2 1935, is hereby amended by inserting after section three
- 3 thousand two hundred ninety-three (3293), Code, 1935, a new
- 4 section designated as section three thousand two hundred ninety-
- 5 three-a one (3293-a1), which shall read as follows:
- 6 3293-a1. Businesss Manager.

7 1. The board shall appoint a business manager for each
8 of the following named institutions: Glenwood state school
9 state sanatorium, Woodward state school and colony, Chero-
10 kee state hospital, Clarinda state hospital, Independence
11 state hospital, and Mount Pleasant state hospital. Said
12 business manager shall be responsible to, and hold office at
13 the pleasure of the board, and shall receive such salary and
14 compensation as shall be fixed pursuant to section six thou-
15 sand two hundred ninety-six (6296),

16 2. Subject to the orders of the board, said business
17 manager shall have the following powers, duties and responsi-
18 bilities:

19 (1) He shall be the general business manager of the
20 institution for which he is appointed, and shall have com-
21 plete charge and supervision over all business matters and
22 affairs relating to such institution, including all farming
23 and industrial projects carried on by such institution.

24 (2) He shall have complete charge and supervision
25 over the condition and repair of the buildings and equip-
26 ment of such institution, subject to the direction of the
27 superintendent in the case of special equipment directly
28 used in laboratory or in the medical, mental, moral, or
29 dietetic treatment or care of patients or inmates.

30 (3) He shall have complete custody and control over
31 all property used in connection with such institution, sub-
32 ject to the direction of the superintendent with regard

33 to supplies and equipment directly used in the laboratory
34 or in the medical, mental, moral, or dietetic treatment or
35 care of any patient or inmate.

36 (4) He shall replace the steward at such institution
37 and shall have all the powers, duties, and responsibilities
38 vested in the steward by section three thousand three hundred
39 twenty-two (3322).

40 (5) He shall appoint, discharge, and keep the record
41 of all employees, as provided in section three thousand two
42 hundred ninety-three (3293), excepting the doctors, orderlies,
43 nurses, ward attendants, laboratory personnel, dieticians,
44 cooks and other professional personnel, which shall be appoin-
45 ted, discharged, and a record thereof kept by the superintendent.

46 (6) He shall exercise no control or direction whatever
47 over the medical, mental, moral or dietetical treatment or care
48 of any patient or inmate of said institution, or over doctors,
49 orderlies, nurses, ward attendants, laboratory personnel, diet-
50 icians, cooks and other professional personnel employed by the
51 superintendent of said institution.

1 Sec. 2. Section three thousand two hundred ninety-two
2 (3292), Code, 1935, is hereby amended by inserting after the
3 word "institution" in line six thereof the words "except the
4 institutions named in section 3293-a1".

1 Sec. 3. Section three thousand two hundred ninety-three
2 (3293), Code, 1935, is hereby amended by striking the word "Such"
3 from line three thereof and inserting in lieu thereof the follow-

4 ing: "Subject to the provisions of section 3293-a1, such"; by
5 inserting after the words "executive officer" in line five thereof
6 the words "or business manager".

1 Sec. 4. Amend section three thousand three hundred (3300),
2 Code, 1935, by inserting after the word "officer" in line three
3 thereof the following: "or the business manager in charge of
4 said officer or employee, as the case may be,".

1 Sec. 5. Section three thousand three hundred thirty (3330),
2 Code, 1935, is hereby amended by inserting at the end thereof
3 the following: "Such report shall be made by the business manager
4 in the case of the institutions named in section 3293-a1."

1 Sec. 6. Section three thousand three hundred thirty-one (3331),
2 Code, 1935, is hereby amended by adding at the end thereof the
3 following: "Such report shall be made by the business manager in
4 the case of the institutions named in
5 section 3293-a1."

1 Sec. 7. Section three thousand three hundred thirty-two
2 (3332), Code, 1935, is hereby amended by adding at the end
3 thereof the following: "Such amount shall be retained by
4 the business manager instead of the superintendent in the
5 case of the institutions named in section 3293-a1."

1 Sec. 8. Section three thousand three hundred fifty-two
2 (3352), Code, 1935, is hereby amended by inserting after the
3 word "institution" in line two thereof the following: ", ex-
4 cept those named in section 3293-a1, and the business manager
5 of the institutions there named,".

1 Sec. 9. Section three thousand three hundred fifty-six
2 (3356), Code, 1935, is hereby amended by inserting after the
3 word "institution" in line ten thereof the words "or business
4 manager, as the case may be,".

1 Sec. 10. Sections three thousand three hundred ninety-five
2 (3395), three thousand three hundred ninety-six (3396), three
3 thousand four hundred six (3406), three thousand four hundred
4 ninety-nine (3499), and three thousand five hundred four (3504),
5 Code, 1935, are hereby amended by striking from each of said
6 sections the word "superintendent" wherever it appears in said
7 sections and inserting in lieu thereof in each of said sections
8 the words "business manager".

1 Sec. 11. Section three thousand four hundred sixty-seven
2 (3467), Code, 1935, is hereby amended by striking therefrom
3 all of subsections four and five.
