COMMITTEE'S NOTE

(This is one of a series of bills to change the name of state board of assessment and review to state tax commission, and segregate in and extend the duties of the state tax commission.

Sections 1566 et seq. relate to the collection of taxes on cigarettes and tobacco by the treasurer of state. Under this bill this is added to the duties of the state tax commission.)

A BILL FOR

An Act to amend sections fifteen hundred sixty-six (1566), fifteen hundred seventy (1570), fifteen hundred seventy-b one (1570-b1), fifteen hundred seventy-b two (1570-b2), fifteen hundred seventy-one (1571), fifteen hundred seventy-four (1574), fifteen hundred seventy-four-a one (1574-a1), fifteen hundred seventy-five (1575), and fifteen hundred seventy-six (1576), chapter seventy-eight (78), Code, 1935, relating to the tax on cigarettes and tobacco and the collection thereof.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section fifteen hundred sixty-six (1566),
 2 Code, 1935, is hereby amended by changing the words "treasurer
 3 of state" to "state tax commission" in line six (6) thereof.

1 Sec. 2. Section fifteen hundred seventy (1570), Code,
 2 1935, is hereby amended by changing the words "treasurer of state"
 3 to "state tax commission" in line three (3) thereof.

1 Sec. 3. Section fifteen hundred seventy-b one (1570-b1),

2 Code, 1935, is hereby amended by changing the words “treasurer
3 of state” to “state tax commission” in lines four (4) and five
4 (5), and by changing the word “treasurer” to “commission” in
5 lines eight (8) and ten (10) and by changing the word “officer”
6 to “commission” in line six (6) thereof.

1 Sec. 4. Section fifteen hundred seventy-b two (1570-b2),
2 Code, 1935, is hereby amended by changing the word “treasurer”
3 to “commission” in line seven (7) and by changing the word “his”
4 to “its” in line eight (8) thereof.

1 Sec. 5. Section fifteen hundred seventy-one (1571),
2 Code, 1935, is hereby amended by changing the word “treasurer
3 of state” to “state tax commission” in line thirteen (13)
4 thereof.

1 Sec. 6. Section fifteen hundred seventy-four (1574),
2 Code, 1935, is hereby amended by changing the words “treasurer
3 of state” to “state tax commission” in line four (4) and in
4 lines nine (9) and ten (10), and by changing the word “him”
5 to “it” in line five (5), and by changing the word “his” to
6 “its” in line nine (9), and by changing the word “treasurer”
7 to “commission” in line seven (7) thereof.

1 Sec. 7. Section fifteen hundred seventy-four-a one
2 (1574-a1), Code, 1935, is hereby amended by changing the word
3 “treasurer” to “commission” in lines three (3) and four (4)
4 thereof.

1 Sec. 8. Section fifteen hundred seventy-five (1575),
2 Code, 1935, is hereby amended by changing the words “treasurer

3 of state” to “state tax commission” in line four (4) and by
4 changing the word “treasurer” to “commission” in lines five
5 (5) and six (6) thereof.

1 Sec. 9. Section fifteen hundred seventy-six (1576), Code,
2 1935, is hereby amended by changing the words “state treasurer”
3 to “state tax commission” in lines one (1), two (2) and seven
4 (7), and by changing the word “his” to “its” in line seven (7).
5 Further amend by striking out the remainder of said section
6 following the word “officer” in line nine (9).

1 Sec. 10. Wherever the word “treasurer”, “state treasurer”
2 or “treasurer of state” appear in said chapter and have not
3 been specifically referred to in this act, the words “state
4 treasurer” and “treasurer of state” are hereby changed to
5 read “state tax commission” and the word “treasurer” is hereby
6 changed to read “commission” and the code editor is hereby
7 authorized to make said changes.
