COMMITTEE'S NOTE

(This is one of a series of bills to change the name of board of assessment and review to state tax commission, and segregate in and extend the duties of the state tax commission.)

Sections 5105-a40 et seq., as amended by Chapter 205, Acts of the 47th G. A., relate to taxation of motor vehicle carriers and collection thereof. This bill removes same from the board of railroad commissioners, now the state commerce commission, to the state tax commission, and repeals that part of Sec. 5105-a54 as takes one-fifth of the amount collected for the purposes of administration.)

A BILL FOR

An Act to amend sections fifty-one hundred five-a forty (5105-a40),
 fifty-one hundred five-a forty-one (5105-a41), and fifty-one
 hundred five-a fifty-four (5105-a54), chapter two hundred
 fifty-two-A two (252-A2), Code, 1935, as amended by chapter
 two hundred five (205), Acts of the Forty-seventh General
 Assembly, relating to the taxation of motor vehicle carriers
 and collection of the tax.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section fifty-one hundred five-a forty (5105-a40),
 2 Code, 1935, as amended by chapter two hundred five (205), Acts
 3 of the Forty-seventh General Assembly, is hereby amended by chang-
 4 ing the words "Iowa state commerce commissioners" to the words
 5 "state tax commission" in line two (2) of subsection four (4)
 6 thereof.
