## A BILL FOR

An Act to amend sections one thousand nine hundred twenty-one and six thousandths (1921.006), one thousand nine hundred twenty-one and ten thousandths (1921.010), one thousand nine hundred twenty-one and eleven thousandths (1921.011), one thousand nine hundred twenty-one and twelve thousandths (1921.012), one thousand nine hundred twenty-one and fourteen thousandths (1921.014), Code, 1939, and to repeal sections one thousand nine hundred twenty-one and seven thousandths (1921.007) and one thousand nine hundred twenty-one and eight thousandths (1921.008), Code, 1939, all relating to the membership of the Iowa Liquor Control.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section one thousand nine hundred twenty-one  
2 and six thousandths (1921.006), Code, 1939, is hereby repealed  
3 and the following enacted in lieu thereof: "there is hereby created  
4 a commission composed of the Auditor of the State of Iowa, the  
5 Secretary of State of Iowa, and the Treasurer of the State of Iowa.  
6 Said commission is to be designated and known as the Iowa Liquor  
7 Control Commission. The commission shall be held strictly account-  
8 able for the enforcement of the provisions of this chapter".

1 Sec. 2. Section one thousand nine hundred twenty-one and  
2 seven thousandths (1921.007), Code, 1939, is hereby repealed.

1 Sec. 3. Section one thousand nine hundred twenty-one and

2 eight thousandths (1921.008), Code, 1939, is hereby repealed.

1 Sec. 4. Section one thousand nine hundred twenty-one and  
2 ten thousandths (1921.010), Code, 1939, is hereby amended by strik-  
3 ing from lines four (4), five (5), six (6) and seven (7) the follow-  
4 ing words: "Each member of the commission shall devote his entire  
5 time to the duties of his office, and his salary shall be four  
6 thousand five hundred dollars (\$4,500.00) a year."

1 Sec. 5. Section one thousand nine hundred twenty-one and  
2 eleven thousandths (1921.011), Code, 1939, is hereby amended by  
3 striking from lines one (1) and two (2) the following words:  
4 "members of the commission and said" and by inserting in lieu  
5 thereof the word "The".

1 Sec. 6. Section one thousand nine hundred twenty-one and  
2 twelve thousandths (1921.012), Code, 1939, is hereby amended by  
3 striking from line one (1) the word "member,"

1 Sec. 7. Section one thousand nine hundred twenty-one and  
2 fourteen thousandths (1921.014), Code, 1939, is hereby amended  
3 by striking from line one (1) the words "member,".
