A BILL FOR

An Act to make appropriations to Mrs. Anna Clark, Des Moines, Iowa, John R. Gardner, Lisbon, Iowa, Herman W. Walter, Council Bluffs, Iowa, F. J. Pine, Columbus Junction, Iowa, Sanford Zeigler, Jr., Fairfield, Iowa, B. C. Whitehill, Marshalltown, Iowa, J. Kendall Lynes, Plainfield, Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the
2 general fund of the State of Iowa to Mrs. Anna Clark,
3 Des Moines, Iowa, the sum of sixty-eight dollars and
4 twenty-five cents (\$68.25) in full settlement of all
5 claims which she may have against the State of Iowa, for
6 injuries sustained by her on September 18, 1941, in
7 connection with a fall at State Historical Building.

1 Sec. 2. There is hereby appropriated out of the
2 general fund of the State of Iowa, to John R. Gardner
3 of Lisbon, Iowa, the sum of twenty dollars (\$20.00)
4 in full settlement of all claims which he may have against
5 the State of Iowa on account of services rendered as
6 member of the Iowa Industrial and Defense Commission.

1 Sec. 3. There is hereby appropriated out of the

2 general fund of the State of Iowa, to Herman W. Walter
3 of Council Bluffs, Iowa, the sum of One hundred sixty
4 dollars (\$160.00) in full settlement of all claims which
5 he may have against the State of Iowa on account of services
6 rendered as a member of Iowa Industrial and Defense Commission.

1 Sec. 4. There is hereby appropriated out of the
2 general fund of the State of Iowa, to F. J. Pine of
3 Columbus Junction, Iowa, the sum of one hundred ten
4 dollars (\$110.00) in full settlement of all claims which
5 he may have against the State of Iowa on account of services
6 rendered as member of Iowa Industrial and Defense Commission.

1 Sec. 5. There is hereby appropriated out of the
2 general fund of the State of Iowa, to Sanford Zeigler, Jr.,
3 of Fairfield, Iowa, the sum of one hundred thirty dollars
4 (\$130.00) in full settlement of all claims which he may
5 have against the State of Iowa on account of services
6 rendered as member of Iowa Industrial and Defense Commission.

1 Sec. 6. There is hereby appropriated out of the
2 general fund of the State of Iowa to B. C. Whitehill,
3 Marshalltown, Iowa, the sum of one hundred thirty
4 dollars (\$130.00), in full settlement of all claims
5 which he may have against the State of Iowa on account of
6 services rendered as member of the Iowa Industrial and
7 Defense Commission.

1 Sec. 7. There is hereby appropriated out of the
2 general fund of the State of Iowa to J. Kendall Lynes,

3 of Plainfield, Iowa, the sum of Three hundred eighty-five
4 dollars (\$385.00) in full settlement of all claims which
5 he may have against the State of Iowa for services performed
6 as member of the Iowa School Code Commission.

1 Sec. 8. The State Comptroller is hereby authorized
2 to issue warrants to the above named parties in the amounts
3 stated, and the State Treasurer is hereby directed to pay
4 the same from the general fund of the State of Iowa.

1 Sec. 9. The acceptance of said amounts by the above
2 named parties shall be in full settlement of all claims
3 against the State of Iowa growing out of the above
4 described claims.
