A BILL FOR

An Act to make appropriations to Henry and Eleanor Broderson, Harlan, Iowa; to Daisy E. Johnson, Des Moines, Iowa; to Herman F. Graff, Minneapolis, Minnesota; to Dr. John Eiel, Osage, Iowa; to Nissen Hospital, Osage, Iowa; to H. R. Harris, Oskaloosa, Iowa

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of
2 the general fund of the State of Iowa to Henry and
3 Eleanor Broderson of Harlan, Iowa, the sum of Six
4 Hundred Dollars (\$600.00) in full settlement of all
5 claims which they may have against the State of Iowa
6 for the death of their minor son, Richard Broderson,
7 resulting from a fall from the third story window at
8 Currier Hall, State University, Iowa City, Iowa.

1 Sec. 2. There is hereby appropriated out of the
2 general fund of the State of Iowa to Daisy S. Johnson
3 of Des Moines, Iowa, the sum of Four Hundred Eighty-
4 six and forty-one hundredths (\$486.41) Dollars in full
5 settlement of all claims which she may have against the
6 State of Iowa on account of expenses and legal fees in-
7 curred in connection with quieting title action on land

8 held by her under erroneous patent from the State of
9 Iowa.

1 Sec. 3. There is hereby appropriated out of the
2 general fund of the State of Iowa to Herman F. Graff of
3 Minneapolis, Minnesota, the sum of One Hundred Dollars
4 (\$100.00) in full settlement of all claims which he may
5 have against the State of Iowa and the Iowa State High-
6 way Commission in connection with the death of his mother,
7 Mrs. Amelia Graff.

1 Sec. 4. There is hereby appropriated out of the
2 general fund of the State of Iowa to Dr. John Eiel of
3 Osage, Iowa, the sum of Eighty (\$80.00) Dollars in full
4 settlement of all claims which he may have against the
5 State of Iowa or the Iowa State Highway Commission for
6 services performed on behalf of Mrs. Amelia Graff of
7 Osage, Iowa, now deceased.

1 Sec. 5. There is hereby appropriated out of the
2 general fund of the State of Iowa to Nissen Hospital of
3 Osage, Iowa, the sum of Forty-seven and twenty-five
4 hundredths (\$47.25) Dollars in full settlement of all
5 claims which it may have against the State of Iowa and
6 the Iowa State Highway Commission for services performed
7 on behalf of Mrs. Amelia Graff of Osage, Iowa, now
8 deceased.

1 Sec. 6. There is hereby appropriated out of the
2 general fund of the State of Iowa to H. R. Harris of

3 Oskaloosa, Iowa, the sum of One Hundred Ninety-five
4 and sixty-two hundredths (\$195.62) Dollars in full
5 settlement of all claims which he may have against the
6 State of Iowa or the Iowa State Highway Commission in
7 connection with a collision with State Highway equipment
8 on October 3, 1941.
