## A BILL FOR

**An Act to make appropriations to John H. Woodman, Martin Funeral Service, Suthpen Funeral Home, Brimhall-West Company, Larkin-Knutson Funeral Home, Claude W. Smith, Paul S. Fry, Olerich Funeral Home, Woodring Funeral Home, Clarence N. Cooper Mortuary, Geo. J. Brosh, White Funeral Home, Carson-Balster Funeral Home, C. El. Wagler, Blust Funeral Service.**

*Be It Enacted by the General Assembly of the State of Iowa:*

1     Section 1. There is hereby appropriated out of the Old  
 2     Age Assistance Fund of the State of Iowa, to John H. Woodman,  
 3     Russell, Iowa, the sum of seventy-five dollars (\$75.00) in full  
 4     settlement of all claims which it may have against the State  
 5     of Iowa on account of funeral expenses for burial of Aaron W.  
 6     Dyer, deceased, recipient of Old Age Assistance.
