A BILL FOR

An Act to make appropriations to Nobles County Cooperative Oil Company, Worthington, Minnesota; Mervin Wogen, Albert Lea, Minnesota; Elmer Jensen, Independence, Iowa; Dessa G. Vanderwilt, Knoxville, Iowa; W. E. Bohl, Buffalo Center, Iowa; R. C. Drake, Crystal Lake, Iowa; J. E. Campbell, Harlan, Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the
2 motor vehicle fuel tax refund fund of the State of Iowa to
3 Nobles County Cooperative Oil Company, Worthington, Minnesota,
4 the sum of three thousand one hundred twenty-seven and 92/100
5 dollars (\$3127.92) in full settlement of all claims it may
6 have against the State of Iowa on account of refund of motor
7 fuel tax on gasoline sold to Iowa customers.

1 Sec. 2. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to Mervin
3 Wogen, Albert Lea, Minnesota, the sum of six dollars (\$6.00)
4 in full settlement of all claims he may have against the
5 State of Iowa on account of refund on plates, which claim
6 was filed too late for payment under statute.

1 Sec. 3. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to Elmer

3 Jensen, Independence, Iowa, the sum of one hundred eighteen
4 and 12/100 dollars (\$118.12) in full settlement of all claims
5 he may have against the State of Iowa on account of refund
6 of motor registration fee on truck.

1 Sec. 4. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to Dessa
3 G. Vanderwilt, Knoxville, Iowa, the sum of four dollars
4 (\$4.00) in full settlement of all claims he may have against
5 the State of Iowa on account of motor vehicle registration
6 refund filed too late for payment under statute.

1 Sec. 5. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to W. E.
3 Bohl, Buffalo Center, Iowa, the sum of two dollars (\$2.00)
4 in full settlement of all claims he may have against the
5 State of Iowa on account of motor vehicle registration
6 refund filed too late for payment under statute.

1 Sec. 6. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to R. C.
3 Drake, Crystal Lake, Iowa, the sum of one dollar (\$1.00) in
4 full settlement of all claims he may have against the State
5 of Iowa on account of motor vehicle registration refund
6 filed too late for payment under statute.

1 Sec. 7. There is hereby appropriated out of the motor
2 vehicle fuel tax refund fund of the State of Iowa to J. E.
3 Campbell, Harlan, Iowa, the sum of four dollars (\$4.00) in
4 full settlement of all claims he may have against the State

5 of Iowa for refund on motor vehicle registration for years
6 1941, 1942, 1943 and 1945.

1 Sec. 8. The State Comptroller is hereby authorized to
2 issue his warrant to the above named parties in the amounts
3 stated, and the State Treasurer is hereby directed to pay the
4 same from the motor vehicle fuel tax refund fund of the State
5 of Iowa.

1 Sec. 9. The acceptance of said sum by the above named
2 parties shall be in full settlement of all claims against
3 the State of Iowa growing out of the above described claims.
