## A BILL FOR

An Act relating to the administration of state budget and finances and to assign or transfer certain duties relating thereto to the auditor of state, state comptroller, or treasurer of state.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section eight point four (8.4), Code 1950,  
2 is amended as follows:

3 1. By striking from line ten (10) the words "in  
4 executive session, of two thirds" and inserting in lieu  
5 thereof the words "of a constitutional majority of the  
6 members".

7 2. By striking from line eleven (11) the words "at his  
8 pleasure" and inserting in lieu thereof the words "for a term  
9 of two years".

1 Sec. 2. Section eight point five (8.5), Code 1950, is  
2 amended by striking all of subsection four (4).

3 (General accounting transferred to auditor, see Sec. 28  
4 of this bill).

1 Sec. 3. Section eight point six (8.6), Code 1950, is  
2 hereby repealed and the following enacted in lieu thereof:

3 "The specific duties of the comptroller shall be:

4 1. Preaudit of claims. To examine the validity and  
5 check the computation of all accounts submitted for the  
6 issuance of warrants and, if found valid and correct, request  
7 the auditor of state to issue his warrant.

8 2. Approve expenditures. To approve no expenditures from  
9 funds other than regular appropriated funds except when  
10 otherwise provided for by law.

11 3. Prepare Budget. To prepare the budget document and  
12 draft the legislation necessary to make it effective.

13 4. Examinations. To examine annually the accounts of all  
14 state departments, commissions, boards, institutions, and  
15 agencies and report any illegal or improper practices.

16 5. Uniform forms. To prescribe all accounting and  
17 business forms and the system of accounts and reports of  
18 financial transactions by all departments and agencies of the  
19 government other than those of the legislative branch.

20 6. Personnel. To appoint a personnel director and  
21 maintain a department of personnel.

22 7. Survey of institutions. To make an annual survey of  
23 all institutions under the board of control and board of  
24 education regarding efficiency, economy of operation, and  
25 future needs, and report his findings and recommendations.

26 8. Capital additions. To investigate proposals or  
27 requests for capital additions to the plant of any department  
28 or institution of the state and make findings as to the cost

29 and need for such additions.

30 9. Comparative costs. To compare the cost of material,  
31 salaries, and wages paid by various departments and report  
32 his findings and recommendations.

33 10. Estimated revenues. To prepare an estimate of  
34 anticipated revenues to the state from every source.

35 11. Allocate funds. To allocate quarterly from  
36 appropriated funds amounts necessary for the operation and  
37 maintenance of various departments and institutions for the  
38 ensuing quarter.

39 12. Allotments. To perform the necessary work involved  
40 in receiving requests for allotments as are submitted to the  
41 governor for approval and furnish a copy thereof to the  
42 auditor of state.

43 13. Conditions of finances. To prepare a statement, to  
44 be submitted with the budget, of the financial condition of  
45 the state.

46 14. Contracts. To certify and record all formal contracts  
47 and furnish information thereof to the auditor for encumbrance  
48 of the proper appropriations or allotments.

49 15. For the purpose of performing the duties of the  
50 comptroller as applied to the state board of control, the  
51 comptroller shall assign an employee of his office to check the  
52 validity of all claims against the board before such claims  
53 are approved by the board. He shall, in the checking of claims  
54 against the board and examination of accounts of the board,

55 be under the direction and supervision of the comptroller.  
56 The state board of control shall furnish said employee of the  
57 comptroller with office space.

9 records, and documents of the treasury department shall be  
10 examined daily.”

14 (c) The work of the department so examined needlessly  
15 conflicts with or duplicates the work done by any other  
16 department.

17 3. All illegal or unbusinesslike practices.

18 4. Any recommendations for greater simplicity, accuracy,  
19 efficiency, or economy, in the operation of the several  
20 departments and institutions.

21 5. Comparisons of prices paid and terms obtained by the  
22 various departments for goods and services of like character  
23 and reasons for differences therein, if any.

24 6. Any other information which, in his judgment, may  
25 be of value to him.

26 All such reports shall be filed and kept in his office  
27 and copies of all individual audit reports of state departments  
28 and establishments and of the daily examination report of the  
29 state treasury shall be transmitted to the auditor of state.

3 "Method of keeping accounts. Each department and  
4 institution of the state shall keep its records and accounts in  
5 such form and by such methods as to be able to exhibit in its

7 otherwise specifically prescribed by law. The failure by the  
8 head of any department to comply with this provision shall be

9 ground for his suspension from office.”

14 exclusive merit system council with power to do all acts  
15 required of merit system councils as a prerequisite or condition  
16 to obtaining grants in aid other than state aid for any state  
17 department, institution, or agency.

18 3. It shall be the duty of the director of personnel to  
19 list and classify all employees of the state.

9 to the state or entrusted with the collection, disbursement,  
10 or management of funds belonging to the same, when they are  
11 payable to or from the state treasury.

12 2. To make settlement with officers. To settle the

13 accounts of all county treasurers and receivers of state  
14 revenues payable into the state treasury, for each of their  
15 official terms, separately.

16 3. To keep accounts of revenues. To keep fair, clear,  
17 and separate accounts of all the revenue, funds, and incomes  
18 of the state payable to the state treasury, and of all  
19 disbursements and investments thereof, showing the particulars  
20 of same.

21 4. To settle with creditors. To settle all claims  
22 against the treasury, and, when a claim has been declared  
23 valid by the comptroller for which no appropriation has been  
24 made or for the payment of which no funds are available, to  
25 give the claimant a certificate thereof and report the same  
26 to the general assembly.

27 5. To make collections. To direct and superintend the  
28 payment of all money payable into the state treasury, and  
29 cause to be instituted and prosecuted the proper actions for  
30 the recovery of debts and money so payable.

31 6. Warrants. To draw warrants on the treasurer for  
32 money authorized by law to be paid out of the treasury, as the  
33 same may be approved by the comptroller. Each warrant shall  
34 bear on its face its proper number, date, amount, name of  
35 payee, and a reference to the law under which it is drawn, and  
36 a statement indicating the purpose for which issued whether for  
37 salaries, wages, services, or supplies, and for what office or  
38 department, which particulars shall be entered in a book kept

39 for that purpose in the order of issuance, and as soon as  
40 practicable after issuing such warrant he shall certify said  
41 particulars to the treasurer.

42 7. Required payee. All warrants shall be drawn to the  
43 order of the person, firm, or contractor entitled to payment  
44 or compensation, except that when goods or materials are  
45 purchased in foreign countries, warrants may be drawn upon  
46 the treasurer of state payable to bearer for net amount of  
47 invoice and current exchange, and the treasurer of state shall  
48 furnish such foreign draft payable to the order of the person,  
49 firm, or corporation from whom purchase is made.

50 8. Prohibited payee. In no case shall warrants be drawn  
51 in the name of the certifying department, board, or  
52 institution, or in the name of an employee of the same, except  
53 for personal service rendered or expense incurred by said  
54 employee, unless there be statutory authority therefor.

55 9. Cancellation of warrants. The auditor, as of March 31,  
56 June 30, September 30, and December 31 of each year, shall  
57 cancel and request the treasurer of state to stop payment on  
58 all state warrants which have been outstanding and unredeemed  
59 by the state treasurer for one year or longer.

60 10. School fund interest. He shall, on the first Monday  
61 of March and September of each year, apportion the interest of  
62 the permanent school fund among the several counties in  
63 proportion to the number of persons between five and twenty-one  
64 years of age in each, as shown by the last report filed with

65 him by the superintendent of public instruction.
