A BILL FOR

An Act to amend sections one hundred sixty-four point one (164.1), one hundred sixty-four point nineteen (164.19), one hundred sixty-five point six (165.6) and one hundred sixty-five point seven (165.7), Code 1950, relating to indemnity to be paid on cows resulting from artificial insemination which are slaughtered in connection with Bang's disease and tuberculosis control programs.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Amend section one hundred sixty-four point
2 one (164.1), Code 1950, by adding thereto the following:
3 " 'Registered daughter' shall mean animals begotten by artificial
4 insemination and having a proof of parentage certificate of
5 registry on animals begotten by artificial insemination."

1 Sec. 2. Amend section one hundred sixty-four point
2 nineteen (164.19), Code 1950, by adding to line ten after the
3 word "animal" the words "or registered daughter".

1 Sec. 3. Amend section one hundred sixty-five point six
2 (165.6), Code 1950, by adding to line nine after the word "or"
3 the following: "registered daughter, and".

1 Sec. 4. Amend section one hundred sixty-five point seven
2 (165.7), Code 1950, by adding thereto the following: "Registered

- 3 daughter shall be proven by a proof of parentage certificate of
- 4 registry on animals begotten by artificial insemination.”.

EXPLANATION OF H. F. 239

Bulletins issued by the agricultural extension service at Iowa State College state that cows resulting from artificial insemination are outproducing the production record of the Dairy Herd Improvement Association, and thus the value of these cows is much greater than animals resulting from pasture breeding. Some recognition should be made of the great advances made in production by this type cattle and it is fitting that this production should be encouraged by the state of Iowa
