A BILL FOR

An Act to make an appropriation from the general fund of the state of Iowa to the department of public instruction for specified school aid.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state of Iowa to the department of public instruction
3 for each year of the biennium beginning July 1, 1953, and ending
4 June 30, 1955, the sum of five hundred seventy-five thousand five
5 hundred dollars (\$575,500.00), or so much thereof as may be
6 necessary, to be used in the following manner:
7 Aid to handicapped children (special education),
8 as provided in chapter two hundred eighty-one (281), Code
9 1950\$526,000.00
10 Normal Institute 49,500.00
11 Total\$575,500.00
