A BILL FOR

An Act to appropriate from the general fund of the state of Iowa to the state soil conservation committee the sum of seven hundred thousand dollars (\$700,000.00) to carry on soil conservation work in soil conservation districts as provided in chapter four hundred sixty-seven A (467A), Code 1950.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. There is hereby appropriated from the general
- 2 fund of the state of Iowa to the state soil conservation
- 3 committee the sum of three hundred fifty thousand dollars
- 4 (\$350,000.00) for each year of the biennium beginning July 1,
- 5 1953, and ending June 30, 1955, or so much thereof as may be
- 6 necessary, to carry on soil conservation work in soil conser-
- 7 vation districts organized under the soil conservation districts
- 8 law of the state of Iowa. The fund will be used as follows:
- 9 1. Aid to soil conservation districts for district
- 10 commissioners expenses, stationery, postage and other uses as
- 11 they may be authorized by the state soil conservation committee;
- 12 five hundred dollars (\$500.00) per district. Total fifty
- 13 thousand dollars (\$50,000.00).
- 14 2. Personnel (technicians and clerical personnel), and
