A BILL FOR

An Act to repeal sections one hundred ninety-four point one (194.1) to one hundred ninety-four point thirteen (194.13) inclusive, Code 1950, relating to the excise tax of five cents (5c) per pound upon oleomargarine.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Sections one hundred ninety-four point one
- 2 (194.1) to one hundred ninety-four point thirteen (194.13),
- 3 inclusive, Code 1950, relating to the excise tax of five cents
- 4 (5c) per pound upon oleomargarine, are hereby repealed.

- 2 enacting clause and inserting in lieu thereof the
- 3 following: "Section 1. Insert after the second comma
- 4 in line five (5) of section one hundred ninety-four point one


