A BILL FOR

An Act to amend section three hundred thirty-one point twenty-two (331.22), Code 1954, and chapter three hundred forty (340) Code 1954, relating to the compensation of county officers.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Sections three hundred forty point one (340.1),
- 2 three hundred forty point three (340.3), three hundred forty
- 3 point five (340.5), and three hundred forty point eleven (340.11),
- 4 Code 1954, are hereby amended by striking therefrom subsections
- 5 one (1) to thirteen (13), inclusive, and inserting in lieu
- 6 thereof:
- 7 "1. Less than ten thousand, thirty-eight hundred dollars.
- 8 2. Ten thousand and less than fifteen thousand, thirty-
- 9 nine hundred fifty dollars.
- 10 3. Fifteen thousand and less than twenty thousand, forty-
- 11 one hundred dollars.
- 12 4. Twenty thousand and less than twenty-five thousand,
- 13 forty-two hundred fifty dollars.
- 14 5. Twenty-five thousand and less than thirty thousand,
- 15 forty-four hundred dollars.

16 6. Thirty thousand and less than thirty-five thousand,
17 forty-five hundred fifty dollars.

18 7. Thirty-five thousand and less than forty thousand,
19 forty-seven hundred dollars.

20 8. Forty thousand and less than forty-five thousand,
21 forty-eight hundred fifty dollars.

22 9. Forty-five thousand and less than fifty thousand,
23 five thousand dollars.

24 10. Fifty thousand and less than sixty thousand, fifty-
25 three hundred dollars.

26 11. Sixty thousand and less than seventy thousand,
27 fifty-six hundred dollars.

28 12. Seventy thousand and less than eighty thousand,
29 fifty-nine hundred dollars.

30 13. Eighty thousand and over, sixty-two hundred dollars."

1 Sec. 2. Section three hundred forty point seven (340.7),
2 Code 1954, is hereby amended by striking therefrom subsections
3 one (1) to fourteen (14) inclusive, and inserting in lieu
4 thereof the following:

5 "1. Less than ten thousand, thirty-eight hundred dollars.

6 2. Ten thousand and less than fifteen thousand, thirty-
7 nine hundred fifty dollars.

8 3. Fifteen thousand and less than twenty thousand, forty-
9 one hundred dollars.

10 4. Twenty thousand and less than twenty-five thousand,
11 forty-two hundred fifty dollars.

12 5. Twenty-five thousand and less than thirty thousand,
13 forty-four hundred dollars.

14 6. Thirty thousand and less than thirty-five thousand,
15 forty-five hundred fifty dollars.

16 7. Thirty-five thousand and less than forty thousand,

2 Code 1954, is hereby amended by striking lines five (5), six (6),
3 and seven (7) thereof.

1 Sec. 4. Section three hundred thirty-one point twenty-two
2 (331.22), Code 1954, is hereby amended by striking from lines
3 three (3) and four (4) thereof the word “ten” and inserting in

4 lieu thereof in each line the word "twelve"; by striking from
5 line nineteen (19) the words "thirty-two hundred" and inserting in
6 lieu thereof the words "thirty-eight hundred"; by striking from
7 line twenty-four (24) the words "thirty-six hundred" and inserting
8 in lieu thereof the words "forty-two hundred"; by striking from
9 line thirty (30) the words "forty-six hundred" and inserting in
10 lieu thereof the words "fifty-two hundred"; by striking from line
11 thirty-four (34) the words "five thousand dollars" and inserting
12 in lieu thereof the words "fifty-six hundred dollars"; by
13 striking from lines thirty-nine (39) and forty (40), the words
14 "four thousand eight hundred" and inserting in lieu thereof the
15 words "fifty-four hundred".

EXPLANATION OF H. F. 246

Salaries should be commensurate with positions of like responsibilities and qualification in other public and private offices, and persons of high caliber, with experience and qualification, would feel more inclined to aspire to public office.

County administration has become more and more complicated and involved, with ever increasing work load, and in other states and in federal government it is recognized that costs of living have increased.
