## A BILL FOR

An Act to amend section six hundred two point forty-nine (602.49), Code 1954, relating to salaries of municipal court clerks and bailiffs.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section six hundred two point forty-nine  
2 (602.49), Code 1954, is amended by striking all of lines fourteen  
3 (14) to twenty-eight (28), inclusive, and substituting in lieu  
4 thereof the following:  
5 "Each clerk shall receive an annual salary of four thousand  
6 dollars in cities of less than thirty thousand inhabitants; four  
7 thousand five hundred dollars in cities of thirty thousand and  
8 less than seventy-five thousand inhabitants; and five thousand  
9 dollars in cities of seventy-five thousand or more inhabitants.  
10 The salary of any clerk of a municipal court whose judge or  
11 judges act as judge of the juvenile court shall be increased in  
12 the sum of two hundred dollars annually.  
13 "Each bailiff shall receive an annual salary of thirty-eight  
14 hundred dollars in cities of less than thirty thousand  
15 inhabitants; four thousand fifty dollars in cities of thirty

16 thousand and less than seventy-five thousand inhabitants; and  
17 four thousand three hundred dollars in cities of seventy-five  
18 thousand or more inhabitants. The salary of each bailiff of a  
19 municipal court whose judge or judges act as judge of the juvenile  
20 court shall be increased in the sum of two hundred dollars  
21 annually.”.

EXPLANATION OF H. F. 330

This is a bill designed to grant minor salary increases to clerks and bailiffs of municipal courts.

1 Amend section one (1), line sixteen (16) by striking  
2 the word “and” following the semi-colon (;) and striking the  
3 period (.) following the word “inhabitants” in line eighteen  
4 (18) and inserting in lieu thereof a semi-colon (;) and add-  
5 ing the following: “five-thousand dollars in cities of one  
6 hundred fifty thousand or more inhabitants.”

12 5. By striking from line fifteen (15) the words “four  
13 thousand fifty” and inserting in lieu thereof the words  
14 “thirty-eight hundred fifty”.  
15 6. By striking from line seventeen (17) the word “three”  
16 and inserting in lieu thereof the word “one”.
