A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for the biennium beginning July 1, 1955, and ending June 30, 1957, to the Board of Control for salaries, supports, maintenance, repairs, replacements, alterations or equipment of institutions under said board of control.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the
2 general fund of the state of Iowa for each year of the
3 biennium beginning July 1, 1955, and ending June 30, 1957,
4 for the board of control of state institutions for salaries,
5 support, maintenance, repairs, replacements, alterations
6 or equipment and miscellaneous purposes for all institutions
7 under the control of said board the sum of fourteen million
8 thirty-five thousand dollars (\$14,035,000.00) or so much
9 thereof as may be necessary to be used for the following
10 purposes to wit:

Cherokee
