6 (5)' and inserting in lieu thereof the word, 'six (6)'.
7 2. By adding after the word, 'judge.' in line twenty-seven
8 (27) the sentence:
9 'The largest county at the last federal census shall have
10 three (3) resident judges.'
11 3. By striking from line thirty-two (32) the word, 'six'
12 and inserting in lieu thereof the word, 'seven (7)'.
13 Sec. 2. The vacancies in the office of district judge
14 created by this Act shall be filled by appointment by the
15 governor. The person so appointed shall hold said office until
16 January 1, 1959, or until his successor is elected and qualified,
17 which successor shall be elected at the general election in 1958,
18 and every four (4) years thereafter.
19 Sec. 3. This Act being deemed of immediate importance shall
20 be in full force and effect from and after publication in the
21 West Des Moines Express, a newspaper published in West Des
22 Iowa, and in the Perry Daily Chief, a newspaper published in
23 Perry, Iowa."
