A BILL FOR

An Act relating to group insurance and to amend Chapter five hundred nine (509) and section five hundred nine point one (509.1), Code 1954.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section five hundred nine point one (509.1),
2 Code 1954, is hereby amended by inserting after the word
3 "provides" in line five (5) of paragraph d, of subsection one (1)
4 thereof the word "term".

1 Sec. 2. Section five hundred nine point one (509.1), Code
2 1954, is hereby further amended by inserting after the word
3 "other" in line six (6) of paragraph d of subsection one (1)
4 thereof the word "term".

1 Sec. 3. Section five hundred nine point one (509.1), Code
2 1954, is hereby further amended by inserting after the word
3 "provides" in line five (5) of paragraph d of subsection four
4 (4) thereof the word "term".

1 Sec. 4. Section five hundred nine point one (509.1), Code
2 1954, is hereby further amended by inserting after the word
3 "other" in line six (6) of paragraph d of subsection four (4)
4 thereof the word "term".

3 "insurance" in line six (6) of paragraph d of subsection five
4 (5) thereof the word "term".

3 line three (3) of subsection five (5) thereof the words "or by
4 one or more employers and by one or more labor unions".

1 Sec. 12. Section five hundred nine point one (509.1), Code
2 1954, is hereby amended by adding to subsection two (2) following
3 paragraph g thereof the following paragraph:

4 "h. A school district to insure the employees of the
5 district."

1 Sec. 13. Section five hundred nine point one (509.1), Code
 2 1954, is hereby further amended by inserting after the word
 3 “company” in line fifteen (15) of paragraph g of subsection two
 4 (2) thereof the following: “, a school district”.

1 Sec. 14. Chapter five hundred nine (509), Code 1954, is
 2 hereby amended by adding thereto the following new section:

3 “The board of directors of any school district may establish
 4 plans for and procure group insurance, which may include life,
 5 accident and health insurance for the employees of such district
 6 and the dependents of such employees.

7 The fund for such group insurance shall be created from (1)
 8 contributions from employees who elect to participate in the plan
 9 for group insurance and (2) contributions authorized by the board
 10 of directors of a school district from the general funds of the
 11 district in amounts not exceeding the aggregate amounts assessed
 12 against and collected from employees who elect to participate in
 13 such plan. Contributions to the group insurance fund by the
 14 board of directors of a school district and expense incurred in
 15 the operation and administration of such plan of group insurance
 16 are hereby designated to be operating expenses of a school
 17 district and such contributions from funds of school districts
 18 are hereby authorized.”
