A BILL FOR

An Act to legalize and validate the proceedings for the organization and establishment of the Boyden-Hull Community School District, in the counties of Sioux and Lyon, State of Iowa, and declaring said district a duly and legally organized corporate body as provided by law.

WHEREAS, pursuant to proceedings taken by the county superintendent of schools of Sioux County, Iowa, and the county boards of education of Sioux and Lyon Counties, Iowa, an election was held on February 10, 1959, on the proposition of establishing a new school district to be known as the Boyden-Hull Community District, in the counties of Sioux and Lyon, State of Iowa, by uniting territory then lying within the boundaries of eleven (11) school corporations located in Sioux and Lyon Counties, Iowa; and

WHEREAS, pursuant to the favorable results of said election, an election of officials has been called, descriptions of the boundaries of the new and enlarged school district were filed with the county auditors of Sioux County and Lyon County, and a new school corporation was organized in accordance with the county plans, effective July 1, 1959, which is known and has been officially designated as the Boyden-Hull Community School District, in the counties of Sioux and Lyon, State of Iowa; and

WHEREAS, doubts have risen concerning the validity and legal sufficiency of the proceedings taken for the organization and establishment of said Boyden-Hull Community School District, in the counties of Sioux and Lyon, State of Iowa; and it is deemed advisable and necessary to put such doubts and all others that might arise concerning same forever at rest; now, therefore,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. All proceedings heretofore taken in con-
- 2 nection with the organization, creation and establish-

3 ment of the school corporation now known and identified
 4 as the Boyden-Hull Community School District, in the
 5 counties of Sioux and Lyon, State of Iowa, are hereby
 6 legalized, validated and confirmed and that said school
 7 district is hereby declared to constitute a legal school
 8 corporation created in conformity with the provisions
 9 of chapter two hundred seventy-five (275), Code 1958,
 10 and the boundaries of said Boyden-Hull Community School
 11 District as now shown by the records of the county audi-
 12 tors of Sioux and Lyon Counties, Iowa, are hereby de-
 13 clared to be the legally established boundaries of
 14 said district.

1 Sec. 2. This Act being of immediate importance shall
 2 be in full force and effect from and after its passage
 3 and publication in the Hull Index, a newspaper pub-
 4 lished at Hull, Iowa, and the Boyden Reporter, a
 5 newspaper published at Boyden, Iowa, without expense
 6 to the state.
