# A BILL FOR

An Act to make an appropriation to pay witness fees, mileage and expenses of witnesses, attorney fees, mileage and expenses for counsel for the parties, and other expenses in the election contests of Clarence E. Lohff, contestant vs. Bert K. Fairchild, incumbent; George Good, contestant vs. Jack N. Milroy, incumbent; Cecil V. Lutz, contestant vs. Stanley Watts, incumbent; and T. J. Frey, contestant vs. Gilbert F. Klefstad and Jack Rooney, incumbents.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated out of the general  
2 fund of the state to the following named persons the amounts set  
3 opposite their names in full payment of all claims they may have  
4 against the state on account of services rendered and expenses  
5 incurred in the following election contests: Clarence E. Lohff,

1     Sec. 2. The state comptroller is hereby authorized to issue  
2 warrants to the above-named parties in the amounts stated, and  
3 the treasurer of state is hereby directed to pay the same from  
4 the general fund of the state.

1     Sec. 3. The acceptance of said sums by the above-named  
2 parties shall be in full settlement of all claims against the  
3 state growing out of the above-described claims.

1     Sec. 4. This Act being deemed of immediate importance shall  
2 take effect and be in full force from and after its publication  
3 in the Marshalltown Times-Republican, a newspaper published  
4 at Marshalltown, Iowa, and the Alta Advertiser, a newspaper  
5 published at Alta, Iowa.
