A BILL FOR

An Act to amend Sec. 154.1, Code 1958, relating to the definition of optometry.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Sec. 154.1, Code 1958, is hereby amended by
- 2 striking subparagraph 1 and inserting in lieu thereof the
- 3 following:
- 4 "Persons employing any means other than the use
- 5 of drugs, medicine or surgery to examine the human eye,
- 6 to determine the visual efficiency of the human eye, or
- 7 to determine the powers or defects of vision; the
- 8 prescribing, furnishing, adapting, using or employing
- 9 lenses, prisms, contact lenses, visual training,
- 10 orthoptics, ocular exercise or any other means or
- 11 device other than the use of drugs, medicine or surgery
- 12 for the aid, relief or correction of vision".

(Committee amendment)

- 1 Amend Senate File 28, section 1, by striking all of lines 4 through 12,
- 2 inclusive,
- 3 and substituting in lieu thereof the following:
- 4 "Persons employing any means other than the use of drugs,
- 5 medicine or surgery for the measurement of the visual power
- 6 and visual efficiency of the human eye; the prescribing and adapting
- 7 of lenses, prisms and contact lenses, and the using or employing
- 8 of visual training or ocular exercise, for the aid, relief or
- 9 correction of vision."
