A BILL FOR

An Act to appropriate from the general fund of the state of Iowa for the biennium beginning July 1, 1961, and ending June 30, 1963, to the board of control for salaries, support, maintenance, repairs, replacements, alterations or equipment of institutions, under said board of control, and to provide that chapter eight (8), except section eight point five (8.5) of the Code, shall apply to this Act.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state of Iowa for each year of the biennium beginning
3 July 1, 1961, and ending June 30, 1963, for the board of control
4 of state institutions for all purposes including salaries, support,
5 maintenance, repairs, replacements, alterations or equipment and
6 miscellaneous purposes for all institutions, under the board of
7 control, the sum of twenty-one million six hundred four thousand
8 eight hundred twenty dollars (\$21,604,820.00), or so much thereof
9 as may be necessary, to be used for the following purposes, to
10 wit:

MENTAL HEALTH INSTITUTE

Cherokee

1 Sec. 2. For the Mental Health Institute at Cherokee, Iowa,
2 there is hereby appropriated from the general fund of the state
3 for each year of the biennium beginning July 1, 1961, and ending
4 June 30, 1963, the sum of two million three hundred thousand
5 dollars (\$2,300,000.00), or so much thereof as may be necessary
6 to be used in the following manner:

 6 of the biennium beginning July 1, 1961, and ending June 30, 1963,
 7 the sum of two hundred thousand seven hundred twenty dollars
 8 (\$200,720.00), or so much thereof as may be necessary to be used

9 in the following manner:

10 For salaries, support, maintenance,
 11 repairs, replacements, alterations or
 12 equipment and miscellaneous purposes\$ 200,720.00

13 The said sum of two hundred thousand
 14 seven hundred twenty dollars (\$200,720.00)

15 shall be used as follows: For mental health
 16 services at the Training School for Boys,
 17 the Training School for Girls, the Juvenile
 18 Home, the Iowa Annie Wittenmyer Home, the
 19 Women's Reformatory, the Men's Reformatory,
 20 and the State Penitentiary.

21 Total for additional mental health\$ 200,720.00

1 Sec. 17. All salaries provided for in this Act shall be
 2 payable in equal monthly or semi-monthly installments, and shall
 3 be in full compensation for all services except as otherwise
 4 expressly provided and except further that expense allowances
 5 shall be authorized, any ruling of the Federal Internal Revenue
 6 Service with respect to the tax status thereof notwithstanding.

1 Sec. 18. Chapter eight (8) of the Code shall apply to
 2 this Act, except that employees whose salaries are appropriated
 3 herein shall not come under the division of personnel under
 4 section eight point five (8.5) of the Code.

1 Sec. 19. A table of organization of all employees earning
 2 twelve thousand dollars (\$12,000.00) or more annually for each
 3 institution must be approved by the budget and financial control
 4 committee before such salaries may be paid from these funds.
 5 Any change in said table of organization must likewise be approved
 6 by said committee before being placed in effect.

3. "Sec. 6. The appropriations provided in this Act to the
4. four state mental institutes, at Cherokee, Clarinda, Independence
5. and Mount Pleasant shall be subject to the following conditions:
6. 1. Eighty percent shall be on a fixed basis.
7. 2. Twenty percent may be transferred as needed from the
8. funds provided for any one of such institutes to the funds of
9. any other of such institutes, subject to the approval of the
10. budget and financial control committee."
