# A BILL FOR

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the general

3 settlement of all claims they may hold against the State of  
4 Iowa on account of damages as above indicated, claims for  
5 which were presented to the joint claims committee of the  
6 Sixtieth General Assembly.
