A BILL FOR

An Act to legalize and validate the proceedings of the boards of directors of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, the Consolidated School District of Orange Township, in the County of Black Hawk, State of Iowa, and the School Township of East Waterloo, in the County of Black Hawk, State of Iowa, providing for the merger of substantial portions of the Consolidated School District of Orange Township and the School Township of East Waterloo into the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, and declaring the enlarged boundaries of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, to be legally established.

WHEREAS, pursuant to concurrent action taken by the boards of directors of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, and the Consolidated School District of Orange Township, in the County of Black Hawk, State of Iowa, on August 5, 1963, the boundary lines of these contiguous school corporations were changed with the approval of the County Board of Education of Black Hawk County, Iowa, so as to include within the boundaries of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, all except four government sections of the land formerly lying within the boundaries of the Consolidated School District of Orange Township, in the County of Black Hawk, State of Iowa, effective July 1, 1964; and

WHEREAS, pursuant to concurrent action taken by the boards of directors of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, and the School Township of East Waterloo, in the County of Black Hawk, State of Iowa, on October 14, 1963, the boundary lines of these contiguous school corporations were changed with the approval of the County Board of Education of Black Hawk County, Iowa, so as to include within the boundaries of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, all except four government sections of the land formerly lying within the boundaries of the School Township of East Waterloo, in the County of Black Hawk, State of Iowa, effective July 1, 1964; and

WHEREAS, complete written descriptions of the new and enlarged boundaries of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, have here-

tofore been filed with the County Auditor and the County Recorder of Deeds of Black Hawk County, Iowa; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of the said proceedings taken for the above described changes in the boundaries of the Independent School District of the City of Waterloo, in the County of Black Hawk, State of Iowa, and it is deemed advisable and necessary to put such doubts and all others that might arise concerning these changes in boundaries forever at rest; now, therefore,

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. That all proceedings heretofore taken by the boards
2 of directors of the Independent School District of the City of
3 Waterloo, in the County of Black Hawk, State of Iowa, the Consol-
4 idated School District of Orange Township, in the County of Black
5 Hawk, State of Iowa, and the School Township of East Waterloo, in
6 the County of Black Hawk, State of Iowa, providing for the enlarge-
7 ment of the boundaries of the Independent School District of the
8 City of Waterloo, in the County of Black Hawk, State of Iowa, by
9 merging substantial portions of the Consolidated School District
10 of Orange Township and the School Township of East Waterloo, into
11 the Independent School District of the City of Waterloo, in the
12 County of Black Hawk, State of Iowa, are hereby legalized, vali-
13 dated and confirmed and the following described boundaries of
14 the Independent School District of the City of Waterloo, in the
15 County of Black Hawk, State of Iowa, being those now shown by the
16 records of the County Auditor of Black Hawk County, Iowa, are
17 hereby declared to be the legally established boundaries of said
18 School District, to-wit:

19 Commencing at the Northwest Corner of Section 32, Township 90
20 North, Range 13 West of the 5th P. M., Black Hawk County, Iowa;
21 Thence East along the North line of said Section to the North-
22 east Corner thereof;

23 Thence South along the East line of said Section to the South-
24 east Corner thereof;

25 Thence East along the North Line of Sections 4, 3, 2, and 1
26 Township 89 North, Range 13 West of 5th P. M., and along the
27 North line of Sections 6 and 5 to the North quarter corner of
28 Section 5, Township 89 North, Range 12 West of the 5th P. M.

29 Thence South along the center line of Sections 5 and 8, Town-
30 ship 89 North, Range 12 to the South quarter corner of said Sec-
31 tion 8;

32 Thence East along the South line of Section 8, 9, and 10, Town-
33 ship 89 North, Range 12 to the South quarter corner of said Section
34 10;

35 Thence South along the center line of Section 15, Township 89
36 North, Range 12 West of 5th P. M. to the center of said Section
37 15;

38 Thence East along the center line of said Section 15 to the
39 East line of said Section 15;

40 Thence South along East line of Section 15 and 22 said Township
41 and Range to the East Quarter Corner of said Section 22;

42 Thence West along the center line of said Section 22 to the
43 center of said Section 22;

44 Thence South along the center line of Section 22 and 27 said
45 Township and Range to the North line of Section 34 said Township
46 and Range;

47 Thence East along the North line of said Section 34 to the
48 Northeast Corner of said Section 34;

49 Thence South along the East line of said Section 34 to the North
50 line of Section 3, Township 88 North, Range 12 West of the 5th
51 P. M.;

52 Thence West along the North line of said Section 3 to the North-
53 east Corner of Section 4 said Township and Range;
54 Thence South along the East line of Section 4 and 9 said Town-
55 ship and Range to a cut off in the Cedar River;
56 Thence along the Easterly line of Lot No. 4 in Section 15,
57 Township 88 North, Range 12 to the East line of Section 16, Town-
58 ship 88 North, Range 12;
59 Thence Southerly along the River to the East quarter corner of
60 Section 27, Township 88 North, Range 12;
61 Thence West to the West quarter corner of said Section 27;
62 Thence South to the southwest corner of said Section 27;
63 Thence West to the southwest corner of Section 28, Township 88
64 North, Range 12;
65 Thence South to the Southeast corner of Section 32, Township
66 88 North, Range 12;
67 Thence West to the Southwest corner of said Section 32;
68 Thence South to the Southeast corner of Section 6, Township 87
69 North, Range 12;
70 Thence West to the Southwest corner of said Section 6;
71 Thence North to the northwest corner of said Section 6;
72 Thence West to the North Quarter corner of Section 2, Township
73 87 North, Range 13;
74 Thence South to the Center of said Section 2;

- 108 Thence North on a line parallel to the east line of Section 29,
109 20, and 17, Township 89 North, Range 13, to the Cedar River.
110 Thence Northerly and Westerly along said Cedar River to the

112 Thence North along the West line of Section 8 and 5 said Town-
113 ship and Range and along the West line of Section 32, Township 90,
114 North, Range 13 West of the 5th P. M., to the place of beginning.
- 1 Sec. 2. This Act, being deemed of immediate importance, shall
2 take effect and be in force from and after its publication in the
3 Waterloo Daily Courier, a newspaper published in Waterloo, Iowa.
