A BILL FOR

An Act to change the names of the state board of public instruction, the state superintendent of public instruction, and the state department of public instruction.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section two hundred fifty-seven point one
2 (257.1), Code 1966, is amended by inserting after the word
3 "members." in line five (5), the following:

4 "From and after July 1, 1967, the state board of public
5 instruction shall be officially known as the state board of
6 education and all statutes, public documents and writings
7 which make reference to the state board of public instruction
8 shall be construed to refer to the state board of education."

1 Sec. 2. Section two hundred fifty-seven point eleven
2 (257.11), Code 1966, is amended by inserting after the word
3 "instruction." in line five (5) the following:

4 "From and after July 1, 1967, the state superintendent of
5 public instruction shall be officially known as the state
6 commissioner of education and all statutes, public documents
7 and writings which make reference to the state superintendent
8 of public instruction shall be construed to refer to the
9 state commissioner of education."

1 Sec. 3. Section two hundred fifty-seven point nineteen
2 (257.19), Code 1966, is amended by inserting after the word
3 "Iowa." in line fourteen (14) the following:

4 "From and after July 1, 1967, the state department of public
5 instruction shall be officially known as the state department

6 of education and all statutes, public documents and writings
