A BILL FOR

An Act relating to the reorganization of the office of state comptroller, including reorganization and reassignment of various state offices and departments including the state printing board, the superintendent of printing, the capitol buildings and grounds department, the superintendent of capitol buildings and grounds, the state car dispatcher, centralized purchasing procedure, assignment of office and department space procedure, mail delivery and messenger service, state and federal surplus property programs, record storage, data processing, partial functions of the armory board and involving other functions and departments.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby established within the office
2 of the state comptroller a division of general services.

1 Sec. 2. The comptroller shall have the following enumerated
2 and additional powers, duties and functions: (a) establish
3 uniform budget asking procedures and analyze and make recom-
4 mendations on departmental budget requests; (b) prepare the
5 governor's budget; (c) forecast revenue estimates; (d) super-
6 vise budget execution; (e) conduct management surveys; (f)
7 develop, administer, supervise and maintain a state program
8 for records management; and develop, administer, supervise
9 and maintain state policy and procedural manuals that shall
10 be used and followed by all state agencies, boards, commis-
11 sions, and departments in their official communications and
12 relations with the division of budget and accounting; (g)
13 establish, administer and supervise a system of fiscal
14 control; (h) develop, administer, supervise and promulgate a

15 uniform state system of accounting; (i) provide for preaudit
16 of payments; (j) maintain central control accounts; (k) main-
17 tain payroll and related records; (l) render financial state-
18 ments; (m) centrally disperse state funds, conduct special
19 studies and prepare reports requested by the governor; and
20 (n) otherwise assist in development and execution of state
21 fiscal policy. The comptroller may, by rule and regulation,
22 provide that the budgets of any licensing boards not within
23 another department, be compiled and submitted as a single
24 budget. Thereafter, the budgets of such licensing boards
25 shall be compiled and submitted in accordance with the comp-
26 troller's ruling. The appropriation made by the general
27 assembly for such licensing boards shall thereafter be con-
28 tained in a single appropriation bill. The comptroller may
29 further assign or reassign duties, powers and responsibilities
30 from one division of his department to another or assign
31 additional duties, powers and responsibilities assigned to
32 him by law to an appropriate division or portion of his
33 department.

1 Sec. 3. The comptroller may establish a division of data
2 processing. When it is determined pursuant to the merit
3 system that a director of this division is warranted, he shall
4 be educated and experienced in the modern techniques involved
5 in the preparation, storage and analysis of data. He shall
6 establish a data processing service center for the benefit of
7 the various state agencies providing for programming and
8 systems analysis services and such other services as will be
9 beneficial.

1 Sec. 4. There is hereby established within the office of
2 the comptroller a division of general services which will be
3 controlled and administered by a director. The director of
4 general services shall be educated and experienced in the
5 areas of institutional purchasing, maintenance of property
6 and equipment, and qualified to administer and control by such
7 education and experience a large number of varied and different

8 departments. He shall have the following duties and powers:

9 1. Establish and develop, in cooperation with the various
10 state agencies, a system of uniform standards and specifica-
11 tions so that items of general use can be purchased through
12 this division.

13 2. Provide for the proper maintenance and protection of
14 state buildings and equipment.

15 3. Arrange for the leasing or rental of all office space
16 for state agencies from private enterprise and to assign space
17 within all state buildings to state agencies.

18 4. Manage the state automotive fleet and establish and
19 administer policies and procedures for the efficient acquisi-
20 tion, maintenance, operation, disposal and use of all state
21 vehicles.

22 5. Provide for a system of centralized printing and dupli-
23 cating.

24 6. Provide for an adequate, efficient and proper mail and
25 messenger service.

26 7. Establish and operate a center for storage of inactive
27 state records, to include microfilming if warranted.

28 8. Establish and administer a state surplus personal prop-
29 erty re-utilization program and serve as the state agency for
30 the federal surplus property program.

1 Sec. 5. This Act shall be effective on January 1, 1968.

1 Sec. 6. From and after January 1, 1968, all of the powers,
2 duties and responsibilities lodged in the state printing board,
3 the superintendent of printing, the superintendent of public
4 buildings and grounds, the state car dispatcher, the state
5 war surplus commodities program, and the administrative func-
6 tions of the capitol planning commission and the armory board
7 are hereby transferred to and lodged in the office of the comp-
8 troller.
