A BILL FOR

An Act relating to the reorganization of the department of public defense.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section twenty-nine point one (29.1), Code
2 1966, is hereby amended as follows:

3 1. By striking from line five (5) the word "and" and by
4 inserting in lieu thereof a comma.

5 2. By inserting after the word "state" in line six (6)
6 the words "and the veterans' affairs division as provided in
7 the laws of this state".

1 Sec. 2. Chapter twenty-nine (29), Code 1966, is hereby
2 amended by inserting the following as a new section thereto:

3 "There shall be within the department of public defense of
4 the state government, as a division thereof, a state veterans'
5 affairs agency which shall be styled and known as the 'veterans'
6 affairs division'. The veterans' affairs division shall be
7 responsible for administering services relating to Spanish
8 war veterans, soldiers' bonuses, war orphans educational aid,
9 war memorials and the registration of graves. The adjutant
10 general shall supervise, direct and control this division."

1 Sec. 3. Section twenty-nine A point seventy-four (29A.74),
2 Code 1966, is hereby amended by striking from line ten (10)
3 the word "forty-eight" and by inserting in lieu thereof the
4 word "fifty (50)".

1 Sec. 4. Section thirty-five point one (35.1), Code 1966,

2 is hereby repealed.

1 Sec. 5. Section thirty-five point two (35.2), Code 1966,
2 is hereby amended by striking from line two (2) the words
3 "bonus board" and by inserting in lieu thereof the words
4 "veterans' affairs division".

1 Sec. 6. Section thirty-five point three (35.3), Code
2 1966, is hereby amended as follows:

3 1. By striking from lines two (2) and three (3) the
4 words "said bonus board" and by inserting in lieu thereof
5 the words "the veterans' affairs division".

6 2. By striking from line five (5) the word "board" and
7 by inserting in lieu thereof the words "the veterans' affairs
8 division".

1 Sec. 7. Section thirty-five point four (35.4), Code
2 1966, is hereby amended by striking from line seven (7) the
3 words "said bonus board" and by inserting in lieu thereof
4 the words "the veterans' affairs division".

1 Sec. 8. Section thirty-five point five (35.5), Code 1966,
2 is hereby amended by striking from line three (3) the words
3 "said bonus board" and by inserting in lieu thereof the
4 words "the veterans' affairs division".

1 Sec. 9. Section thirty-five point six (35.6), Code 1966,
2 is hereby amended as follows:

3 1. By striking from lines one (1) and two (2) the words
4 "Said bonus board" and by inserting in lieu thereof the
5 words "The veterans' affairs division".

6 2. By striking from line three (3) the word "board" and
7 by inserting in lieu thereof the words "veterans' affairs
8 division".

1 Sec. 10. Section thirty-five point seven (35.7), Code
2 1966, is hereby amended by striking from lines one (1) and
3 two (2) the words "bonus board" and by inserting in lieu
4 thereof the words "veterans' affairs division".

1 Sec. 11. Section thirty-five point nine (35.9), Code 1966,

2 is hereby amended as follows:

3 1. By striking from lines one (1) and two (2) the words
4 "Said bonus board" and by inserting in lieu thereof the words
5 "The veterans' affairs division".

6 2. By striking from line twenty-three (23) the words
7 "said bonus board" and by inserting in lieu thereof the
8 words "the veterans' affairs division".

1 Sec. 12. Section thirty-five point ten (35.10), Code
2 1966, is hereby amended as follows:

3 1. By striking from line three (3) the words "Iowa bonus
4 board" and by inserting in lieu thereof the words "the
5 veterans' affairs division".

6 2. By striking from lines sixteen (16), seventeen (17),
7 and twenty-two (22) the words "bonus board" and by inserting
8 in lieu thereof the words "veterans' affairs division".

1 Sec. 13. Section thirty-six point one (36.1), Code
2 1966, is hereby repealed and the following enacted in lieu
3 thereof:

4 "The veterans' affairs division of the department of
5 public defense shall be responsible for determining the loca-
6 tion in this state of the unmarked graves of soldiers or
7 sailors who served in the war of the American revolution, and
8 to supervise, as herein provided, the erection over each of
9 such unmarked graves of a suitable marker or monument."

1 Sec. 14. Sections thirty-six point two (36.2) and thirty-
2 six point three (36.3), Code 1966, are hereby repealed.

1 Sec. 15. Section thirty-six point four (36.4), Code
2 1966, is hereby amended by striking from line one (1) the
3 words "Said commission" and by inserting in lieu thereof the
4 words "The veterans' affairs division".

1 Sec. 16. Section thirty-six point five (36.5), Code 1966,
2 is hereby amended as follows:

3 1. By striking from lines two (2) and three (3) the words
4 "commission or a majority thereof" and by inserting in lieu
5 thereof the words "veterans' affairs division".

6 2. By striking from lines five (5) and six (6) the word
7 "commission" and by inserting in lieu thereof the words
8 "veterans' affairs division".

1 Sec. 17. Section thirty-six point six (36.6), Code 1966,
2 is hereby amended as follows:

3 1. By striking from lines one (1) and two (2) the word
4 "commission" and by inserting in lieu thereof the words
5 "veterans' affairs division".

6 2. By striking from lines two (2) and three (3) the word
7 "commission" and by inserting in lieu thereof the words
8 "veterans' affairs division".

1 Sec. 18. Section thirty-six point seven (36.7), Code 1966,
2 is hereby repealed.

1 Sec. 19. Section thirty-five A point seven (35A.7), Code
2 1966, is hereby amended as follows:

3 1. By striking from lines two (2) and three (3) the words
4 "bonus board created by section 35.1" and by inserting in lieu
5 thereof the words "veterans' affairs division".

6 2. By striking from lines eight (8), fourteen (14), eighteen
7 (18), thirty-one (31), thirty-four (34), forty-one (41), fifty-
8 three (53) and fifty-four (54) the words "bonus board" and by
9 inserting in lieu thereof the words "veterans' affairs division".

10 3. By striking from lines fifty-one (51) and fifty-three
11 (53) the words "said bonus board" and by inserting in lieu
12 thereof the words "veterans' affairs division".

1 Sec. 20. Section thirty-five A point eight (35A.8), Code
2 1966, is hereby amended by striking from lines four (4) and
3 five (5) the words "bonus board" and by inserting in lieu
4 thereof the words "veterans' affairs division".

1 Sec. 21. Section thirty-five A point thirteen (35A.13),
2 Code 1966, is hereby amended as follows:

3 1. By striking from line one (1) of subsection five (5)
4 the words "bonus board" and by inserting in lieu thereof the
5 words "veterans' affairs division".

6 2. By striking from line ten (10) of subsection six (6)
7 the words "bonus board" and by inserting in lieu thereof the
8 words "veterans' affairs division".

1 Sec. 22. Section thirty-five B point six (35B.6), Code
2 1966, is hereby amended by striking from lines three (3) and
3 four (4) the words "bonus board created by section 35.1" and
4 by inserting in lieu thereof the words "veterans' affairs
5 division".

1 Sec. 23. Section thirty-five B point seven (35B.7), Code
2 1966, is hereby amended as follows:

3 1. By striking from line two (2) the words "said board"
4 and by inserting in lieu thereof the words "veterans' affairs
5 division".

6 2. By striking from lines forty-seven (47) and forty-nine
7 (49) the words "said board" and by inserting in lieu thereof
8 the words "the veterans' affairs division".

9 3. By striking from lines seven (7), thirteen (13), seven-
10 teen (17), thirty (30), thirty-two (32), thirty-nine (39) and
11 fifty-one (51) the word "board" and by inserting in lieu
12 thereof the words "veterans' affairs division".

1 Sec. 24. Section thirty-five B point eight (35B.8), Code
2 1966, is hereby amended as follows:

3 1. By striking from line four (4) the word "board" and by
4 inserting in lieu thereof the words "veterans' affairs divi-
5 sion".

6 2. By striking from line five (5) the words "said board"
7 and by inserting in lieu thereof the words "the veterans'
8 affairs division".

1 Sec. 25. "All the powers, duties and responsibilities per-
2 taining to Spanish war veterans pursuant to chapter thirty-
3 seven (37) of the Code; soldiers' bonuses pursuant to chapters
4 thirty-five (35), thirty-five A (35A) and thirty-five B (35B)
5 of the Code; war orphans educational aid pursuant to chapter
6 thirty-five (35) of the Code; war memorials pursuant to chap-
7 ter thirty-seven (37) of the Code and the registration of
