1 Section 1. There is appropriated from the general fund  
2 of the state to the office of the state comptroller and its  
3 divisions for each year of the biennium beginning July 1,  
4 1973 and ending June 30, 1975, the following amounts, or so  
5 much thereof as may be necessary, to be used for the follow-  
6 ing purposes:

27 Sec. 2. All federal grants to and the federal receipts  
28 of the commission are appropriated for the purpose set forth  
29 in such federal grants or receipts.

30 Sec. 3. Notwithstanding the provisions of section eight  
31 point thirty-three (8.33) of the Code, all unencumbered or  
32 unobligated balances of appropriations made by this Act for  
33 the first fiscal year of the biennium commencing July 1, 1973  
34 shall, on August 31, 1974, revert to the state treasury and  
35 to the credit of the fund from which appropriated. In all

1 other respects the provisions of section eight point thirty-  
2 three (8.33) of the Code shall apply to appropriations made  
3 for the first fiscal year of such biennium. Unencumbered  
4 or unobligated balances of appropriations made for the second  
5 fiscal year of such biennium shall be subject to section eight  
6 point thirty-three (8.33) of the Code.

7       Sec. 4. When any of the laws of this state are in conflict  
8 with this Act, the provisions of this Act shall govern for  
9 the biennium.
