A BILL FOR

1 An Act relating to the issuance of trapping licenses to aliens
2 or nonresidents and making provisions of the act retroactive.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section one hundred ten point one (110.1),
2 lines one (1) through fifty-eight (58), inclusive, Code 1973,
3 are amended to read as follows:

4 Except as otherwise provided in this chapter, no person
5 shall fish, trap, hunt, pursue, catch, kill or take in any
6 manner, or use or have possession of, or sell or transport
7 all or any portion of any wild animal, bird, game or fish,
8 the protection and regulation of which is desirable for the
9 conservation of the resources or the state, without first
10 procuring a license or certificate so to do and the payment
11 of a fee as follows:

12 Fishing licenses:

13 All persons legal residents of the state,
14 except as otherwise provided \$4.00

15 All persons legal residents of the state
16 and sixty-five years of age or older,
17 except as otherwise provided 3.00

18 No person, resident or nonresident, required to have a
19 fishing license, shall fish for trout in waters designated
20 by the state conservation commission as "trout waters" without
21 having a special license stamp affixed to his fishing license.
22 Special trout fishing license stamp 5.00

23 The proceeds from the sale of this stamp shall be used
24 exclusively to restock the "trout waters" designated by the
25 state conservation commission.

26 Hunting licenses:

27 All persons legal residents of the state
28 except as otherwise provided 5.00

29 All persons legal residents of the state,
30 and sixty-five years of age or older,
31 except as otherwise provided 3.00

32 Hunting and fishing combined licenses:

33 All persons legal residents of the state,
34 except as otherwise provided 8.00

35 All persons legal residents of the state,

1 and sixty-five years of age or older,
2 except as otherwise provided 5.00
3 Hunting license for nonresident or alien 25.00
4 Special deer hunting license:
5 All persons legal residents of the state 10.00
6 Fishing license (resident and nonresident):
7 One-day license for resident, nonresi-
8 dent, or alien 1.00
9 Fishing license (nonresident):
10 Six-day license for nonresident or alien 5.00
11 Fishing license for longer than six days
12 (nonresident):
13 Fishing license for nonresident or alien 10.00
14 Game breeder's license 10.00
15 Trapping license for legal resident of
16 state under sixteen years of age 1.00
17 Trapping license for legal resident of
18 state sixteen years of age and older 5.00
19 ~~Trapping license for nonresident or alien 10.00~~

20 Sec. 2. Chapter one hundred ten (110), Code 1973, is
21 amended by adding the following new section:

22 NEW SECTION. NONRESIDENT TRAPPING LICENSE--RECIPROCITY.

23 The commission shall issue a trapping license to a nonresident
24 or alien under the same conditions and upon payment of the
25 same fee as if he was a legal resident of this state if the
26 state in which such nonresident or alien is a resident
27 reciprocates by issuing a trapping license to any legal
28 resident of this state under the same conditions and payment
29 of the same fee as if he was a legal resident of such other
30 state.

31 Sec. 3. The provisions of this Act relating to the fee
32 for nonresident or alien trapping licenses and the provisions
33 of section two (2) of this Act shall be retroactive to January
34 1, 1974. Any fees collected during calendar year 1974 for
35 nonresident or alien trapping licenses shall be refunded to

1 the licensee and the licenses shall be canceled.

2 EXPLANATION

3 This bill authorizes the issuance of trapping licenses
4 to nonresidents or aliens under the conditions as if they
5 are legal residents of Iowa if the state in which they are
6 residents provide legal residents of Iowa a license under
7 the same conditions as if they are legal residents of such
8 other state.

9 The fee for a nonresident or alien trapping license is
10 stricken.
