A BILL FOR

1 An Act relating to the private sale, control, distribution and
2 taxation of wine containing not more than seventeen percent
3 alcohol by weight, declaring certain acts relating to wine
4 to be unlawful and prescribing penalties therefor.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

7 retail permittee authorized to sell wine shall
8 sell such wine for off-premise consumption for
9 less than cost adjusted to the nearest cent. Cost,
10 for the purposes of this section, shall be the
11 invoice cost to the retailer plus a minimum markup
12 of twenty percent above invoice cost."

1 Section 1. Section one hundred twenty-three point one
2 (123.1), Code 1973, is amended to read as follows:

3 123.1 PUBLIC POLICY DECLARED. This chapter shall be cited
4 as the "Iowa Beer, Wine and Liquor Control Act", and shall
5 be deemed an exercise of the police power of the state, for
6 the protection of the welfare, health, peace, morals, and
7 safety of the people of the state, and all its provisions
8 shall be liberally construed for the accomplishment of that
9 purpose, and it is declared to be public policy that the traf-
10 fic in alcoholic liquors is so affected with a public interest
11 that it should be regulated to the extent of prohibiting all
12 traffic in them, except as provided in this chapter.

13 Sec. 2. Section one hundred twenty-three point two (123.2),
14 Code 1973, is amended to read as follows:

15 123.2 GENERAL PROHIBITION. It shall be unlawful to manu-
16 facture for sale, sell, offer or keep for sale, possess, or
17 transport alcoholic liquor, wine or beer except upon the
18 terms, conditions, limitations, and restrictions enumerated
19 in this chapter.

20 Sec. 3. Section one hundred twenty-three point three
21 (123.3), subsections four (4), seven (7), eight (8), and ten
22 (10), Code 1973, are amended to read as follows:

23 4. "Local authority" means the city or town council of
24 any incorporated city or town in this state, or the county
25 board of supervisors of any county in this state, which is
26 empowered by this chapter to approve or deny applications
27 for retail beer or wine permits and liquor control licenses;
28 to recommend that such permits or licenses be granted and
29 issued by the department; and to take such other actions as
30 are reserved to them by this chapter.

31 7. "Wine" means any beverage containing alcohol obtained
32 by the fermentation of the natural sugar contents of fruits
33 or other agricultural products and containing not more than
34 seventeen percent alcohol by weight.

35 8. "Alcoholic liquor", "alcoholic beverage" or "intoxi-

1 cating liquor" includes the ~~three~~ two varieties of liquor
2 defined in subsections ~~5-6-7-and-7~~ five (5) and six (6) of
3 this section, except beer as defined in subsection 9 of this
4 section but including all beverages made as described in such
5 subsection which contain more than four percent of alcohol
6 by weight, and every liquid or solid, patented or not, con-
7 taining alcohol, spirits, or wine containing more than seven-
8 teen percent alcohol by weight, and susceptible of being con-
9 sumed by a human being, for beverage purposes.

10 10. "Person" means any individual, association, partner-
11 ship, corporation, club, hotel or motel, or municipal corpo-
12 ration owning or operating a bona fide airport, marina, park,
13 coliseum, auditorium, or recreational facility in or at which
14 the sale of alcoholic liquor, wine or beer is only an inci-
15 dental part of such ownership or operation.

16 Sec. 4. Section one hundred twenty-three point three
17 (123.3), subsection eleven (11), paragraph c, Code 1973, is
18 amended to read as follows:

19 c. He is not prohibited by the provisions of section
20 123.40 from obtaining a liquor control license, wine or beer
21 permit.

22 Sec. 5. Section one hundred twenty-three point three
23 (123.3), subsections thirteen (13), seventeen (17), nineteen
24 (19), twenty (20), twenty-five (25), twenty-six (26), twenty-
25 seven (27), and thirty-one (31), Code 1973, are amended to
26 read as follows:

27 13. "Permit" or "license" means an express written autho-
28 rization issued by the department for the manufacture or sale,
29 or both, of alcoholic liquor, wine or beer.

30 17. "Distillery", "winery", and "brewery" means not only
31 the premises wherein alcohol or spirits is distilled, or rec-
32 tified wine is fermented, or beer is brewed, but in addition
33 a person owning, representing, or in charge of such premises
34 and the operations conducted thereon, including the blending
35 and bottling or other handling and preparation of alcoholic

1 liquor, wine or beer in any form.

2 19. "Importer" means the person transporting or ordering,
3 authorizing, or arranging the transportation of alcoholic
4 liquor, wine or beer into this state whether such person is
5 a resident of this state or not.

6 20. "Import" means the transporting or ordering or ar-
7 ranging the transportation of alcoholic liquor, wine or beer
8 into this state whether by a resident of this state or not.

9 25. The prohibited "sale" of alcoholic liquor, wine or
10 beer under this chapter includes soliciting for sales, taking
11 orders for sales, keeping or exposing for sale, delivery or
12 other trafficking for a valuable consideration promised or
13 obtained, and procuring or allowing procurement for any other
14 person.

15 26. "Wholesaler" means any person, other than a vintner,
16 brewer or bottler of beer or wine, who shall sell, barter,
17 exchange, offer for sale, have in possession with intent to
18 sell, deal or traffic in alcoholic liquor, wine or beer.
19 No wholesaler shall be permitted to sell for consumption upon
20 the premises.

21 27. "Retailer" means any person who shall sell, barter,
22 exchange, offer for sale, or have in possession with intent
23 to sell any alcoholic liquor for consumption on the premises
24 where sold, or beer or wine for consumption either on or off
25 the premises where sold.

26 31. "Licensed premises" or "premises" means all rooms
27 or enclosures where alcoholic beverages, wine or beer are
28 sold or consumed under authority of a liquor control license,
29 wine or beer permit.

30 Sec. 6. Section one hundred twenty-three point three
31 (123.3), Code 1973, as amended by Acts of the Sixty-fifth
32 General Assembly, 1973 Session, chapter one hundred forty
33 (140), is amended by adding the following new subsection:

34 NEW SUBSECTION. "Retail wine permit" means a class "B"
35 or class "C" wine permit issued under the provisions of this

1 chapter.

2 Sec. 7. Section one hundred twenty-three point four
3 (123.4), Code 1973, is amended to read as follows:

4 123.4 DEPARTMENT CREATED--PLACE OF BUSINESS. There is
5 hereby created an Iowa beer and liquor control department
6 to administer and enforce the laws of this state concerning
7 beer, wine and alcoholic liquor. The principal place of
8 business of the department shall be in the city of Des Moines,
9 and suitable quarters or offices shall be provided the de-
10 partment in such city by the authority designated by law to
11 provide such quarters or offices to state departments or
12 agencies.

13 Sec. 8. Section one hundred twenty-three point fourteen
14 (123.14), subsections one (1) and three (3), Code 1973, are
15 amended to read as follows:

16 1. The division of beer and liquor law enforcement of
17 the department of public safety, created pursuant to section
18 80.25, shall be the primary beer, wine and liquor law en-
19 forcement authority for this state.

20 3. The division of beer and liquor law enforcement shall
21 be allowed full access to all records, reports, audits, tax
22 reports and all other documents and papers in the department
23 pertaining to liquor licensees, wine and beer permittees and
24 their business.

25 Sec. 9. Section one hundred twenty-three point fifteen
26 (123.15), Code 1973, is amended to read as follows:

27 123.15 HEARING BOARD ESTABLISHED. There is hereby created
28 a three-member hearing board for the purpose of conducting
29 departmental hearings relating to controversies concerning
30 the issuance, suspension, or revocation of special liquor
31 permits, liquor control licenses, wine and beer permits
32 authorized under this chapter. One member shall be appointed
33 by the council from its membership, which member may be peri-
34 odically replaced by appointment of another council member;
35 one member shall be the attorney general or his designee;

1 and one member shall be the commissioner of public safety
2 or his designee. The hearing board shall establish and adopt
3 rules and procedures for conducting departmental hearings
4 under this chapter.

5 Sec. 10. Section one hundred twenty-three point sixteen
6 (123.16), subsection two (2), paragraph b, Code 1973, is
7 amended to read as follows:

8 b. The granting or refusing of liquor licenses and per-
9 mits, wine and beer permits, and the suspension or revoca-
10 tion of such licenses and permits.

11 Sec. 11. Section one hundred twenty-three point eighteen
12 (123.18), Code 1973, is amended to read as follows:

13 123.18 FAVORS FROM LICENSEE OR PERMITTEE. No person re-
14 sponsible for the administration or enforcement of this chap-
15 ter shall accept or solicit donations, gratuities, political
16 advertising, gifts, or other favors, directly or indirectly,
17 from any liquor control licensee, wine or beer permittee.
18 A violation of this section shall subject the violator to
19 the general penalties provided by this chapter.

20 Sec. 12. Section one hundred twenty-three point nineteen
21 (123.19), subsection one (1), Code 1973, is amended to read
22 as follows:

23 1. Any manufacturer, distiller, ~~vintner~~, or importer of
24 alcoholic beverages shipping, selling, or having alcoholic
25 beverages brought into this state for resale by the state
26 shall, as a condition precedent to the privilege of so traf-
27 ficking in alcoholic liquors in this state, annually make
28 application for and shall hold a distiller's certificate of
29 compliance which shall be issued by the director for such
30 purpose. No brand of alcoholic liquor shall be sold by the
31 department in this state unless the manufacturer, distiller,
32 ~~vintner~~, importer, and all other persons participating in
33 the distribution of such brand in this state have obtained
34 such certificate. Such certificate of compliance shall ex-
35 pire at the end of one year from the date of issuance and

1 shall be renewed for a like period upon application to the
2 director unless otherwise suspended or revoked for cause.
3 Each application for a certificate of compliance or renewal
4 thereof shall be made in such manner and upon such forms as
5 shall be prescribed by the director and shall be accompanied
6 by a fee of fifty dollars payable to the department. How-
7 ever, the provisions of this subsection need not apply to
8 a manufacturer, distiller, ~~vintner~~, or importer who ships
9 or sells in this state no more than eleven gallons or its
10 case equivalent during any fiscal year as a result of "spe-
11 cial orders" which might be placed, as defined and allowed
12 by departmental rules adopted under this chapter.

13 Sec. 13. Section one hundred twenty-three point twenty-
14 one (123.21), subsections six (6) and ten (10), Code 1973,
15 are amended to read as follows:

16 6. Providing for the issuing and distributing of price
17 lists showing the price to be paid by purchasers for each
18 brand, class, or variety of liquor kept for sale under this
19 chapter. Provide for the filing or posting of prices be-
20 tween class "A" beer and wine permit holders and retailers
21 as provided in this chapter, and establish or control such
22 prices as may be based on minimum standards of fill, quantity,
23 or alcoholic content for each individual sale of intoxicating
24 liquor, wine or beer as deemed necessary for retail or con-
25 sumer protection.

26 10. Prescribing the time, manner, means, and method by
27 which distillers, ~~vintners~~, vendors, or others authorized
28 under this chapter may deliver or transport alcoholic liquors
29 and prescribing the time, manner, means, and methods by which
30 alcoholic liquor may be lawfully conveyed, carried, or trans-
31 ported.

32 Sec. 14. Section one hundred twenty-three point twenty-
33 two (123.22), unnumbered paragraph one (1), Code 1973, is
34 amended to read as follows:

35 The department shall have the sole and exclusive right

1 of importation, into the state, of all forms of alcoholic
2 liquor, except as otherwise provided in this chapter, and
3 no person shall so import any such alcoholic liquor, except
4 that an individual of legal age may import and have in his
5 possession an amount of alcoholic liquor not exceeding one
6 quart or, in the case of alcoholic liquor personally obtained
7 outside the United States, one gallon for personal consump-
8 tion only in a private home or other private accommodation.
9 No distillery shall sell any alcoholic liquor within the state
10 to any person but only to the department, except as otherwise
11 provided in this chapter. It is the intent of this section
12 to vest in the department exclusive control within the state
13 both as purchaser and vendor of all alcoholic liquor sold
14 by distilleries within the state or imported therein, except
15 beer and wine, and except as otherwise provided in this
16 chapter.

17 Sec. 15. Section one hundred twenty-three point twenty-
18 nine (123.29), subsection four (4), paragraph c, Code 1973,
19 is amended to read as follows:

20 c. That neither the applicant, if he is an individual,
21 nor any members of the firm or officers of the corporation,
22 if the applicant is not an individual, has been convicted
23 of any violation of the laws of this state with reference
24 to the sale of alcoholic liquors, wine or beer within the
25 three years preceding the date of the affidavit.

26 Sec. 16. Section one hundred twenty-three point thirty
27 (123.30), subsection three (3), paragraphs a, b, c, and d,
28 Code 1973, are amended to read as follows:

29 a. CLASS "A". A class "A" liquor control license may
30 be issued to a club and shall authorize the holder to pur-
31 chase alcoholic liquors from the department only, and to sell
32 such liquors, wine and beer, to bona fide members and their
33 guests by the individual drink for consumption on the premises
34 only.

35 b. CLASS "B". A class "B" liquor control license may

1 be issued to a hotel or motel and shall authorize the holder
2 to purchase alcoholic liquors from the department only, and
3 to sell such liquors, wine and beer, to patrons by the in-
4 dividual drink for consumption on the premises only, however,
5 wines and beer may also be sold for consumption off the
6 premises. Each such license shall be effective throughout
7 the premises described in the application.

8 c. CLASS "C". A class "C" liquor control license may
9 be issued to a commercial establishment but must be issued
10 in the name of the individual or individuals who actually
11 own the entire business and shall authorize the holder or
12 holders to purchase alcoholic liquors from the department
13 only, and to sell such liquors, wine and beer, to patrons
14 by the individual drink for consumption on the premises only,
15 however, wine and beer may also be sold for consumption off
16 the premises.

17 d. CLASS "D". A class "D" liquor control license may
18 be issued to a railway corporation, to an air common carrier,
19 and to passenger-carrying boats or ships for hire with a ca-
20 pacity of twenty-five persons or more operating in inland
21 or boundary waters, and shall authorize the holder to sell
22 or furnish alcoholic beverages, wine and beer to passengers
23 for consumption only on trains, watercraft as described here-
24 in, or aircraft, respectively. Each such license shall be
25 valid throughout the state as a state license. Only one such
26 license shall be required for all trains, watercraft, or air-
27 craft operated in the state by the licensee.

28 Sec. 17. Section one hundred twenty-three point thirty-
29 two (123.32), subsections one (1), two (2), four (4), and
30 five (5), Code 1973, are amended to read as follows:

31 1. FILING OF APPLICATION. An application for a class
32 "A", class "B", or class "C" liquor control license, and for
33 a retail beer permit as provided in sections 123.128 and
34 123.129, or for a retail wine permit as hereinafter provided
35 accompanied by the required fee and bond, shall be filed with

1 the appropriate city or town council if the premises for which
2 the license or permit is sought are located within the corpo-
3 rate limits of a city or town, or with the board of supervi-
4 sors if the premises for which the license or permit is sought
5 are located outside the corporate limits of a city or town.
6 An application for a class "D" liquor control license and
7 for a class "A" beer or wine permit, accompanied by the re-
8 quired fee and bond, shall be filed with the department, which
9 shall proceed in the same manner as in the case of an appli-
10 cation approved by local authorities.

11 2. ACTION BY LOCAL AUTHORITIES. The local authority shall
12 either approve or disapprove the issuance of a liquor control
13 license or retail wine or beer permit, and shall endorse such
14 approval or disapproval on the application and forward same
15 along with the required fee and bond to the department. Upon
16 the initial issuance of a liquor control license or retail
17 beer or wine permit, the fact that the local authority
18 determines that no liquor control license or retail beer or
19 wine permit shall be issued shall not be held to be arbi-
20 trary, capricious, or without reasonable cause. There shall
21 be no limit upon the number of liquor control licenses or
22 retail beer or wine permits which may be approved for issu-
23 ance by local authorities.

24 4. APPEAL TO HEARING BOARD. Any applicant for a liquor
25 control license, wine or beer permit may appeal to the de-
26 partment hearing board, established pursuant to section 123.15,
27 from the director's disapproval of an application for a li-
28 cense or permit. If, upon such appeal the hearing board shall
29 determine that the local authority acted arbitrarily, capri-
30 ciously, or without reasonable cause in disapproving the ap-
31 plication, or that, where the local authority approved the
32 application, the director's own disapproval should be reversed,
33 it shall order issuance of a license or permit. The same
34 right of appeal to the hearing board shall be afforded a li-
35 quor control licensee, wine or beer permittee whose license

1 or permit has been suspended or revoked under this chapter,
2 and the hearing board shall reduce the period of suspension
3 or order reinstatement of such license or permit for good
4 cause shown.

5 5. APPEAL TO COURTS. Any applicant who feels aggrieved
6 by a decision of the director or local authority disapprov-
7 ing, suspending, or revoking issuance of a liquor control
8 license, wine or beer permit may, provided he has exercised
9 his right of appeal to the hearing board as provided in sub-
10 section 4 of this section, appeal from said decision within
11 ten days to the district court of the county wherein the prem-
12 ises covered by the application are situated.

13 Where the hearing board on an appeal by an applicant finds
14 that the local authority acted arbitrarily, capriciously,
15 or without reasonable cause in disapproving an application
16 and the director issues a license or permit, the local author-
17 ity may appeal from such decision within ten days to the dis-
18 trict court of the county wherein the premises covered by
19 the application are situated.

20 Sec. 18. Section one hundred twenty-three point thirty-
21 three (123.33), Code 1973, is amended to read as follows:

22 123.33 RECORDS. Every holder of a liquor control license
23 shall keep a daily record of the gross receipts of his busi-
24 ness. Each bottle emptied, except beer or wine bottles, shall
25 be broken immediately by the licensee or his agent into a
26 container provided for that purpose. The records herein
27 required and the premises of the licensee shall be open to
28 agents of the division of beer and liquor law enforcement
29 of the department of public safety during normal business
30 hours of the licensee.

31 Sec. 19. Section one hundred twenty-three point thirty-
32 four (123.34), Code 1973, is amended to read as follows:

33 123.34 EXPIRATION--SEASONAL LICENSE OR PERMIT. All li-
34 quor control licenses, wine and beer permits, unless sooner
35 suspended or revoked, shall expire one year from date of is-

1 suance. The director shall cause sixty days' notice of such
2 expiration to be given to each licensee or permittee in writ-
3 ing. However, the director may issue six-month or eight-month
4 seasonal licenses or class "B" beer or wine permits for a
5 proportionate part of the license or permit fee. No refund
6 shall be made for seasonal licenses or permits. No seasonal
7 license or permit shall be renewed except after a period of
8 two months.

9 Sec. 20. Section one hundred twenty-three point thirty-
10 five (123.35), Code 1973, is amended to read as follows:

11 123.35 SIMPLIFIED RENEWAL PROCEDURE. The director shall
12 prescribe simplified application forms for the renewal of
13 liquor control licenses, wine and beer permits issued under
14 the provisions of this chapter, which may be filed by licen-
15 sees and permittees in lieu of a detailed renewal application
16 form when qualifications and qualification information have
17 not changed since the original issuance of the license or
18 permit. Such simplified form shall require the licensee or
19 permittee to verify under oath that the information contained
20 in the original application remains current, and that no rea-
21 son exists for the department's refusal to renew the license
22 or permit as originally issued.

23 Such application, accompanied by the required fee and bond,
24 shall be filed in the same manner as is provided for filing
25 the initial application.

26 Sec. 21. Section one hundred twenty-three point thirty-
27 six (123.36), subsection two (2), Code 1973, as amended by
28 Acts of the Sixty-fifth General Assembly, 1973 Session, chapter
29 one hundred sixty-four (164), section one (1), is amended
30 to read as follows:

31 2. Class "A" liquor control licenses, the sum of six hun-
32 dred dollars, except that for class "A" licenses in towns
33 of less than two thousand population, and for clubs of less
34 than two hundred fifty members, the license fee shall be four
35 hundred dollars; however, the fee shall be two hundred dol-

1 lars for any club which is a post, branch, or chapter of a
2 veterans organization chartered by the Congress of the United
3 States, if such club does not sell or permit the consumption
4 of alcoholic beverages or beer or wine on the premises more
5 than one day in any week, and if the application for a license
6 states that such club does not and will not sell or permit
7 the consumption of alcoholic beverages or beer or wine on
8 the premises more than one day in any week.

9 Sec. 22. Section one hundred twenty-three point thirty-
10 seven (123.37), Code 1973, is amended to read as follows:

11 123.37 POWER TO LICENSE AND LEVY TAXES. The power to
12 establish licenses and permits and levy taxes as imposed in
13 title VI of the Code is vested exclusively with the state.
14 Unless specifically provided, no local authority shall levy
15 a local tax on the sale of alcoholic beverages, wine or beer,
16 require the obtaining of a special license or permit for such
17 sale on any establishment, or require the obtaining of a li-
18 cense by any person as a condition precedent to his employ-
19 ment in the sale, serving, or handling of alcoholic beverages,
20 wine or beer within an establishment operating under a li-
21 cense or permit.

22 Sec. 23. Section one hundred twenty-three point thirty-
23 eight (123.38), unnumbered paragraphs one (1) and two (2),
24 Code 1973, are amended to read as follows:

25 A special liquor permit, liquor control license, wine or
26 beer permit shall be a purely personal privilege and be re-
27 vocable for cause. It shall not constitute property nor be
28 subject to attachment and execution nor be alienable nor as-
29 signable, and in any case it shall cease upon the death of
30 a permittee or licensee. However, the director may in his
31 discretion allow the executor or administrator of a permittee
32 or licensee to operate the business of the decedent for a
33 reasonable time not to exceed the expiration date of the per-
34 mit or license. Every permit or license shall be issued in
35 the name of the applicant and no person holding a permit or

1 license shall allow any other person to use same.

2 Any such licensee or permittee, or his executor, adminis-
3 trator, or any person duly appointed by the court to take
4 charge of and administer the property or assets of the li-
5 censee or permittee for the benefit of his creditors, may
6 voluntarily surrender such license or permit to the depart-
7 ment and when so surrendered the department shall notify the
8 local authority, and the department and such local authority,
9 or the local authority by itself in the case of a retail beer
10 permit, or the department by itself in the case of being the
11 sole issuing authority for licenses and permits and for the
12 money it retains for wine permits, shall refund to the per-
13 son so surrendering the license or permit a proportionate
14 amount of the fee paid for such license or permit as follows:
15 If surrendered during the first three months of the period
16 for which said license or permit was issued the refund shall
17 be three-fourths of the amount of the fee; if surrendered
18 more than three months but not more than six months after
19 issuance the refund shall be one-half of the amount of the
20 fee; if surrendered more than six months but not more than
21 nine months after issuance the refund shall be one-fourth
22 of the amount of the fee. No refund shall be made, however,
23 for any special liquor permit, nor for a liquor control
24 license, wine or beer permit surrendered more than nine months
25 after issuance. No refund shall be made to any licensee or
26 permittee, upon the surrender of his license or permit, if
27 there is at the time of said surrender a complaint filed with
28 the department or local authority, charging him with a
29 violation of the provisions of this chapter. If upon hearing
30 on any such complaint the license or permit is not revoked
31 or suspended, then the licensee or permittee shall be eligibile,
32 upon surrender of his license or permit, to receive a refund
33 as herein provided. But if his license or permit is revoked
34 or suspended upon such hearing he shall not be eligibile for
35 the refund of any portion of his license or permit fee.

1 Sec. 24. Section one hundred twenty-three point thirty-
2 nine (123.39), Code 1973, is amended to read as follows:

3 123.39 SUSPENSION OR REVOCATION OF LIQUOR LICENSE, WINE
4 OR BEER PERMIT. Any liquor control license, wine or beer
5 permit issued under this chapter may, after notice in writing
6 to the license or permit holder and reasonable opportunity
7 for hearing, and subject to section 123.50 where applicable,
8 be suspended for a period not to exceed one year or revoked
9 by the local authority or the director for any of the follow-
10 ing causes:

11 1. Misrepresentation of any material fact in the appli-
12 cation for such license or permit.

20 from receiving such license or permit when originally issued.

21 5. Any sale, hypothecation, or transfer of such license
22 or permit.

23 6. The failure or refusal on the part of any licensee
24 or permittee to render any report or remit any taxes to the
25 department under this chapter when due.

26 Local authorities shall have the power to suspend any re-
27 tail wine or beer permit or liquor control license for a
28 violation of any ordinance or regulation adopted by such lo-
29 cal authority. Local authorities are empowered to adopt or-
30 dinances or regulations for the location of the premises of
31 retail wine or beer and liquor control licensed establish-
32 ments and are empowered to adopt ordinances, not in conflict
33 with the provisions of this chapter and that do not diminish
34 the hours during which beer, wine or alcoholic beverages may
35 be sold or consumed at retail, governing any other activities

1 or matters which may affect the retail sale and consumption
2 of beer, wine and alcoholic liquor and the health, welfare
3 and morals of the community involved.

8 the state as a state permit. Only one such permit shall be
9 required for all cars operated in this state by such applicant,
10 but a duplicate of such permit shall be posted in each car
11 in which such beverages are sold; and no further permit shall
12 be required or tax levied for the privilege of selling beer
13 and wine for consumption in such cars. As a condition
14 precedent to the issuing of any such permit, the applicant
15 shall give bond to the department, with good and sufficient
16 sureties thereon to be approved by the director, conditioned
17 upon faithful compliance with the provisions of this chapter
18 in the penal sum of one thousand dollars.

19 Sec. 52. Section one hundred twenty-three point one hun-
20 dred thirty-four (123.134), subsections two (2) and three
21 (3), Code 1973, are amended to read as follows:

22 2. The annual permit fee for a class "B" permit except
23 for a class "B" wine permit shall be graduated according
24 to population as follows:

25 a. For premises located within the corporate limits of
26 cities with a population of ten thousand and over, three hun-
27 dred dollars.

28 b. For premises located within the corporate limits of
29 cities or towns with a population of at least fifteen hun-
30 dred but less than ten thousand, two hundred dollars.

31 c. For premises located within the corporate limits of
32 towns with a population of under fifteen hundred, one hun-

18 Sec. 53. Section one hundred twenty-three point one hun-
19 dred thirty-four (123.134), Code 1973, is amended by adding
20 the following new subsections:

21 NEW SUBSECTION. The annual permit fee for a class "A"
22 wine permit shall be two hundred fifty dollars.

23 NEW SUBSECTION. The annual permit fee for a class "B"
24 wine permit shall be two hundred dollars.

25 NEW SUBSECTION. The annual permit fee for a class "C"
26 wine permit holder whose food sales represent at least seventy-
27 five percent of his total dollar volume shall be graduated
28 on a basis of the amount of interior floor space which com-
29 prises the retail sales area of the premises covered by the
30 permit as follows:

31 a. Up to two thousand five hundred square feet, the sum
32 of seventy-five dollars.

10 Sec. 54. Section one hundred twenty-three point one hun-
11 dred thirty-five (123.135), Code 1973, is amended by adding
12 the following new subsection:

13 NEW SUBSECTION.

14 a. Any manufacturer, vintner, bottler, importer, or ven-
15 dor of wine or any agent thereof desiring to ship, sell, or
16 have wine brought into this state for resale by a class "A"
17 permittee shall first make application for and shall be is-
18 sued a vintner's certificate of compliance by the director
19 for such purpose. Such certificate of compliance shall ex-
20 pire at the end of one year from the date of issuance and
21 shall be renewed for a like period upon application to the
22 director unless otherwise revoked for cause. Each applica-
23 tion for a certificate of compliance or renewal thereof shall
24 be accompanied by a fee of one hundred dollars payable to
25 the department. Each holder of a certificate of compliance
26 shall furnish such information and in such form as the di-
27 rector may require. Any vintner, or wine bottler whose plant

31 mean the granting of more favorable prices, allowances, re-

19 f. No signs or other matter advertising any brand of wine
20 shall be erected or placed upon the outside of any premises
21 which are occupied by a licensee or permittee authorized to

24 authorized to sell wine shall sell such wine for off-premise
25 consumption for less than cost adjusted to the nearest cent.
26 Cost, for the purposes of this section, shall be determined

30 for sales of wine at retail whether in case lot or less.

15 to wine, class "A", "B" or "C" wine permittee or retail liquor
16 licensee who shall violate any of the provisions of this sec-
17 tion shall be subject to a fine not to exceed one thousand
18 dollars or be subject to suspension of the certificate of
19 compliance, license or permit for a period not to exceed one
20 year or be subject to both such fine and suspension.

21 Sec. 55. Chapter one hundred twenty-three (123), Code
22 1973, is amended by adding the following new section:

23 NEW SECTION. WINE GALLONAGE TAX. There shall be levied
24 and collected from all class "A" permittees selling wine on
25 all wine manufactured for sale or sold in this state at
26 wholesale and on all wine imported into this state for sale
27 at wholesale and sold in this state at wholesale, a tax of
28 forty cents for every wine gallon, and at the like rate for

32 Every person holding a class "A" permit shall on or before

35 person is issued a permit, make a report under oath to the

1 department upon forms to be furnished by the department for
2 such purpose showing the exact number of barrels of beer,

1 Sec. 59. Section one hundred twenty-three point one hun-
2 dred forty (123.140), Code 1973, is amended to read as fol-
3 lows:

4 123.140 SEPARATE LOCATIONS--CLASS "B" OR "C". Every per-
5 son holding a class "B" or class "C" permit having more than
6 one place of business where such beer or wine is sold shall
7 be required to have a separate license for each separate place
8 of business, except as otherwise provided by this chapter.

9 Sec. 60. Section one hundred twenty-three point one hun-
10 dred forty-one (123.141), Code 1973, is amended to read as
11 follows:

12 123.141 KEEPING LIQUOR WHERE BEER IS SOLD. No alcoholic
13 liquor for beverage purposes shall be used, or kept for any
14 purpose in the place of business of class "B" permittees,
15 or on the premises of such class "B" permittees, at any time.
16 A violation of any provision of this section shall be grounds
17 for suspension or revocation of the permit pursuant to sec-
18 tion 123.50, subsection 3. This section shall not apply in
19 any manner or in any way, to any railway car of any dining
20 car company, sleeping car company, railroad company or rail-
21 way company, having a special class "B" permit; to the prem-

22 and remitted with the permit application to the department,
23 shall be refunded by the department to the local authority

7 EVIDENCE. The label on any bottle, keg, barrel, or other
8 container in which beer or wine is offered for sale in this
9 state, representing the alcoholic content of such beer as
10 being in excess of four per centum by weight or in the case
11 of wine as representing the alcoholic content of such wine
12 as being in excess of seventeen per centum by weight shall
13 be conclusive evidence as to the alcoholic content of the
14 beer or wine contained therein.

15 EXPLANATION

16 This bill would place wines containing not more than seven-
17 teen percent alcohol by weight under private distribution
18 and sale much the same as beer is handled presently.

19 Wine wholesalers and retailers would be required to ob-
20 tain a separate and distinct wine permit with the exception
21 of the retail liquor licensee who presently has the privilege
22 of selling wine for on-premise consumption.

23 The "mark-up" system for obtaining wine profits for the
24 state would be replaced with a wine excise tax, collected
25 by wholesalers remitting to the state on a monthly basis,
26 and permit fees.

27 Iowa is one of only six states which still maintain an
28 almost complete monopoly over wine sales. Several of these
29 remaining states are considering getting out of the business
30 because the state, in some instances, cannot properly stock,
31 care for nor meet public demand for wines due in part to the
32 natural characteristics of wine.
