## A BILL FOR

1 An Act relating to the payment of relocation assistance to  
2 persons displaced by public projects.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section three hundred sixteen point ten  
 2 (316.10), Code 1973, is amended to read as follows:  
 3 316.10 APPLICABLE TO OTHER THAN FEDERAL-AID HIGHWAYS.  
 4 The commission or any political subdivision ~~may~~ shall provide  
 5 all ~~er-a-part~~ of the programs and payments authorized under  
 6 this chapter to persons displaced by any street or highway  
 7 project which is financed in whole or in part by the state  
 8 or a political subdivision, which is not a federal-aid  
 9 project, and which requires the purchase or condemnation  
 10 of private property for public use. ~~Fe-the-extent-that-a~~  
 11 ~~program-or-payment-is-provided-under-this-section,-it-shall~~  
 12 ~~be-provided-on-a-uniform-basis-to-all-persons-so-displaced.~~  
 13 The commission shall make departmental rules and regulations  
 14 to assure reasonable standards which ~~need-not~~ shall conform  
 15 to federal rules and guidelines, for programs and payments  
 16 provided under this section.

17 Sec. 2. Section three hundred sixteen point eleven (316.11),  
 18 Code 1973, is amended to read as follows:

19 316.11 ACQUISITIONS BY OTHER STATE AGENCIES AND POLITICAL  
 20 SUBDIVISIONS. Whenever real property is acquired by a state  
 21 agency or a political subdivision of the state incident to a  
 22 federal project or program, the state agency or political sub-  
 23 division ~~is-hereby-authorized-and~~ shall make all payments and  
 24 provide all services required by this chapter ~~of-the-commission~~  
 25 ~~in-order-to-secure-the-federal-funds-available-for-such-project~~  
 26 ~~or-program.~~

27 EXPLANATION

28 This bill requires the state and its political subdivisions  
 29 to pay relocation assistance in all public projects where persons  
 30 are displaced and that this assistance shall be provided under  
 31 the provisions of chapter 316.
