1 Section 1. Section one hundred eleven A point three
2 (111A.3), Code 1975, is amended to read as follows:
3 111A.3 MEETINGS--ANNUAL REPORT. Within thirty days after
4 their appointment, the board shall organize by selecting from
5 its members a president and secretary and such other officers
6 as are deemed necessary, who shall hold office for the calendar
7 year in which elected and until their successors are selected
8 and qualify. Three members of the board shall constitute
9 a quorum for the transaction of business. The board shall
10 hold regular monthly meetings. Special meetings may be called
11 by the president, and shall be called on the request of a
12 majority of members, as the necessity may require. The county
13 conservation board ~~shall have power to~~ may adopt bylaws,
14 ~~to~~ adopt and use a common seal, and ~~to~~ enter into contracts.
15 The ~~county~~ board of supervisors shall provide suitable ~~offices~~
16 ~~for the meetings of~~ office space for the county conservation
17 board and its employees, and for the safekeeping of its
18 records. If the board of supervisors declares, by resolution,
19 that suitable office space is not available, the county
20 conservation board may acquire, construct, equip, and maintain
21 an office facility with moneys from the county conservation
22 fund. Any moneys appropriated from the county conservation
23 fund for the acquisition, construction, equipping, or
24 maintenance of an office facility shall be first approved
25 by the board of supervisors. Such The records of the county
26 conservation board shall be subject to public inspection at
27 all reasonable hours and under such regulations as the county
28 conservation board may prescribe. ~~Said~~ The county conservation
29 board shall annually make a full and complete report to the
30 county board of supervisors of its transactions and operations
31 for the preceding year. Such report shall contain a full
32 statement of its receipts, disbursements, and the program
33 of work for the period covered, and may include such
34 recommendations as may be deemed advisable. A copy of this
35 report shall be filed with the state conservation commission.

The bill authorizes the county conservation board to rent, construct, equip, and maintain office space with funds from the county conservation fund if the board of supervisors cannot provide adequate office space in the county courthouse or other county building. The board of supervisors must first approve the appropriation of the county conservation funds for this purpose.
