3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section. 1.

2 1. There is appropriated from the dairy industry fund
3 to the Iowa dairy industry commission under chapter one hundred
4 seventy-nine (179) of the Code for the fiscal year beginning
5 July 1, 1975 and ending June 30, 1976, the following amounts,
6 or so much thereof as may be necessary, to be used for the
7 following purposes:

9 Fiscal Year

10 For salaries, support, maintenance,
11 equipment and miscellaneous purposes,
12 excluding refunds, promotional, and
13 research expenses..... \$45,000

14 2. The remainder of the dairy industry fund is appropri-
15 ated to be used to pay refunds as provided by chapter one
16 hundred seventy-nine (179) of the Code and to pay promotional
17 and research expenses deemed appropriate by the dairy industry
18 commission.

19 Sec. 2. Notwithstanding the provisions of section eight
20 point thirty-three (8.33) of the Code, all unencumbered or
21 unobligated balances of appropriations made by this Act for
22 the fiscal year beginning July 1, 1975 remaining on June 30,
23 1976 shall revert to the dairy industry fund on August 31,
24 1976. In all other respects the provisions of section eight
25 point thirty-three (8.33) of the Code shall apply to this
26 Act.

27 EXPLANATION

28 This bill authorizes the Iowa dairy industry commission
29 to spend funds from the dairy industry fund for purposes set
30 forth in chapter 179 of the Code.

AN ACT
TO APPROPRIATE MONEY FROM THE DAIRY INDUSTRY FUND TO THE
IOWA DAIRY INDUSTRY COMMISSION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1.

1. There is appropriated from the dairy industry fund to the Iowa dairy industry commission under chapter one hundred seventy-nine (179) of the Code for the fiscal year beginning July 1, 1975 and ending June 30, 1976, the following amounts, or so much thereof as may be necessary, to be used for the following purposes:

1975-76
Fiscal Year

For salaries, support, maintenance, equipment and miscellaneous purposes, excluding refunds, promotional, and research expenses..... \$45,000

2. The remainder of the dairy industry fund is appropriated to be used to pay refunds as provided by chapter one hundred seventy-nine (179) of the Code and to pay promotional and research expenses deemed appropriate by the dairy industry commission.

Sec. 2. Notwithstanding the provisions of section eight point thirty-three (8.33) of the Code, all unencumbered or unobligated balances of appropriations made by this Act for the fiscal year beginning July 1, 1975 remaining on June 30, 1976 shall revert to the dairy industry fund on August 31,

1976. In all other respects the provisions of section eight point thirty-three (8.33) of the Code shall apply to this Act.
