13 The sum of \$252,500 is appropriated to the Department of

16 improvements; \$20,000 for repairs to existing elevators; and
17 \$50,000 to the communications division's communications
18 telephone revolving fund for conversion of the presently used
19 centrex I system to the centrex II system.

APPROPRIATING FUNDS TO THE DEPARTMENT OF GENERAL SERVICES FOR
CAPITAL IMPROVEMENTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state for fiscal period beginning July 1, 1976 the following amounts or so much thereof as is necessary to be used for the purposes designated:

- 1. General services--building and grounds for capital improvements and repairs..... \$202,500
- 2. General services--communications division for conversion of the centrex I system to a centrex II system..... \$ 50,000
