 29 (1) of this Act shall be paid from the reimbursement fund

 32 of the claims shall be paid from the general fund of the  
 33 state.

34 Sec. 3. The general assembly disapproves all other claims  
 35 submitted and considered by the committee on claims as of

1 May 12, 1978.

2 EXPLANATION

3 This bill appropriates funds for claims filed against the  
4 state which were referred to the general assembly by the state  
5 appeal board. Section 25.3 of the Code provides for the state  
6 appeal board to file with the general assembly a list of all  
7 claims rejected by the state appeal board and other  
8 information. This bill represents the action of the committee  
9 on claims of the House and Senate in approving or disapproving  
10 such claims.
