1 Section 1. There is appropriated from the general fund  
2 of the state for the fiscal year beginning July 1, 1977 and  
3 ending June 30, 1978 to the following boards the following

16 3. Notwithstanding the provisions of chapters one hundred  
17 eighteen (118) and one hundred eighteen A (118A) of the Code,  
18 it is the intent of the general assembly that the two boards  
19 for which funds are appropriated by this Act shall employ  
20 commencing January 1, 1978 one full-time permanent secretary  
21 to serve both boards. The two boards shall agree on the  
22 method of payment of salary and benefits for such secretary  
23 in consultation with the state comptroller.

24 Sec. 2. All federal grants to and the federal receipts  
25 of the agency receiving funds under this Act are appropriated  
26 for the purpose set forth in the federal grants or receipts.

27 EXPLANATION

28 This appropriation provides for the consolidation of sup-  
29 portive services so that both boards will be served by the  
30 same secretary after December 31, 1977. Funds are provided  
31 to maintain the current level of appropriation until that  
32 date, following which the staff merger is to take place.
