1 Section 1. Section three hundred forty point eight (340.8),
2 Code 1977, as amended by Acts of the Sixty-seventh General
3 Assembly, 1977 Session, chapter one hundred ten (110), section
4 one (1), is amended to read as follows:

5 340.8 DEPUTY SHERIFFS.

6 1. Each deputy sheriff shall receive an annual salary
7 as follows:

8 a. The first deputy sheriff, and the second deputy sheriff
9 if a second deputy sheriff is required, shall receive an an-
10 nual salary of not more than eighty-five percent of the amount
11 of the salary of the sheriff, ~~as fixed by the board of supervi-~~
12 ~~sers.~~

13 b. In counties over two hundred fifty thousand population
14 where more than two deputies are required, ~~said~~ the first
15 and second deputies shall be paid an amount not to exceed
16 seventy-five percent of the annual salary of the sheriff.

17 c. All other deputy sheriffs shall receive an annual
18 salary ~~as fixed by the board of supervisors, but not to~~ which
19 shall not exceed the salaries of the first or second deputies.

20 2. Upon certification by the sheriff to the board of
21 supervisors of the annual salary for each deputy as ~~above~~
22 provided in subsection one (1) of this section, the board
23 of supervisors ~~may~~ shall certify to the county auditor of
24 any such county the annual salary certified by the sheriff,
25 but the board of supervisors shall not certify a salary amount
26 which exceeds the limitations provided in subsection one (1)
27 of this section. The board of supervisors shall fix all
28 compensation for extra help and clerks.

29 EXPLANATION

30 This bill provides that the sheriff shall determine and
31 certify the annual salaries of the deputy sheriffs within
32 the specified salary limitations. The board of supervisors
33 shall certify the salaries received from the sheriff to the
34 county auditor if such salaries are within the specified
35 limitations.

22 supervisors of the annual salary for each deputy as ~~above~~

24 of supervisors ~~may~~ shall certify to the county auditor of
25 any such county the annual salary certified by the sheriff,
26 but the board of supervisors shall not certify a salary amount
27 which exceeds the limitations provided in subsection one (1)

29 compensation for extra help and clerks.
