1 Section 2. Section twenty point nineteen (20.19), Code  
2 1977, is amended by adding the following new unnumbered  
3 paragraph:

4 NEW UNNUMBERED PARAGRAPH. The time schedules specified  
5 in this section and sections twenty point twenty (20.20),  
6 twenty point twenty-one (20.21), and twenty point twenty-two  
7 (20.22) of the Code are directory.

8 Sec. 2. Section twenty point twenty-two (20.22), subsection  
9 one (1), Code 1977, is amended to read as follows:

10 1. If an impasse persists after the findings of fact and  
11 recommendations are made public by the fact-finder, the parties  
12 may continue to negotiate or, the board shall have the power,  
13 upon request of either party, to arrange for arbitration,  
14 which shall be binding. The board shall provide for binding  
15 arbitration after the certified budget submission date if  
16 the employee organization requested the commencement of  
17 negotiations reasonably in advance of the certified budget  
18 submission date. The request for arbitration shall be in  
19 writing and a copy of the request shall be served upon the  
20 other party.

21 EXPLANATION

22 This bill provides that the time schedules specified for  
23 carrying out impasse procedures under collective bargaining  
24 are directory. The bill also requires the public employment  
25 relation board to provide for binding arbitration after the  
26 certified budget submission date if the employee organization  
27 requested the commencement of negotiations reasonably in  
28 advance of the certified budget submission date.
