1 Section 1. Section four hundred twenty-two point forty-
2 three (422.43), unnumbered paragraph nine (9), Code 1979,
3 is amended to read as follows:

4 The following enumerated services shall be subject to the
5 tax herein imposed on gross taxable services: Alteration
6 and garment repair; armored car; automobile repair; battery,
7 tire and allied; investment counseling (excluding investment
8 services of trust departments); bank service charges; barber
9 and beauty; boat repair; car wash and wax; carpentry; roof,
10 shingle, and glass repair; dance schools and dance studios;
11 dry cleaning, pressing, dyeing, and laundering; electrical
12 repair and installation; engraving, photography, and
13 retouching; equipment rental; excavating and grading; farm
14 implement repair of all kinds; flying service, except
15 agricultural aerial application services and aerial commercial
16 and charter transportation services; furniture, rug, upholstery
17 repair and cleaning; fur storage and repair; golf and country
18 clubs and all commercial recreation; house and building moving;
19 household appliance, television, and radio repair; jewelry
20 and watch repair; machine operator; machine repair of all
21 kinds; motor repair; motorcycle, scooter, and bicycle repair;
22 oilers and lubricators; office and business machine repair;
23 painting, papering, and interior decorating; parking lots;
24 pipe fitting and plumbing; wood preparation; private employment
25 agencies; printing and binding; sewing and stitching; shoe
26 repair and shoeshine; ~~storage-warehousing-of-raw-agricultural~~
27 ~~products~~; telephone answering service; test laboratories;
28 termite, bug, roach, and pest eradicators; tin and sheet metal
29 repair; turkish baths, massage, and reducing salons;
30 vulcanizing, recapping, and retreading; weighing; welding;
31 well drilling; wrapping, packing, and packaging of merchandise
32 other than processed meat, fish, fowl and vegetables; wrecking
33 service; wrecker and towing.

34 Sec. 2. This Act is effective January first following
