2 Code 1979, is amended by striking the section and inserting
3 in lieu thereof the following:

4 310.10 FARM-TO-MARKET ROAD SYSTEM DEFINED. The farm-to-
5 market road system shall embrace those roads as defined in
6 section three hundred six point three (306.3), subsection
7 five (5), of the Code.

8 Sec. 2. This Act, being deemed of immediate importance,
9 shall take effect from and after its publication in the
10 Muscatine Journal, a newspaper published in Muscatine, Iowa,
11 and in the Fort Dodge Messenger, a newspaper published in
12 Fort Dodge, Iowa.

13 EXPLANATION

14 The bill removes a conflict in section 310.10 as to what
15 constitutes a farm-to-market road system and adopts by
16 reference the definition of farm-to-market road system in
17 section 306.3, subsection 5, of the Code.

8 may not be reclassified as part of the farm-to-market
9 road system or the local secondary road system by
10 the functional classification board or the department
11 without prior approval of the county board of
12 supervisors of each affected county."
