13 EXPLANATION

14 This bill authorizes HMO contractual provisions to include
15 "reasonable" deductibles and coinsurance charges. Under cur-
16 rent Iowa law the deductibles and coinsurance charges are
17 required to be those contained in federal government contracts
18 with HMOs. The bill revises Iowa's law to conform with the
19 model HMO law proposed by the National Association of Insurance
20 Commissioners.
