1 Section 1. Section 331.441, subsection 2, paragraph b,
2 Code 1983, is amended by adding the following new subpara-
3 graph:

4 NEW SUBPARAGRAPH. (8) Acquisition, construction, recon-
5 struction, improvement, repair, and equipping of water works,
6 water mains and extensions, and real and personal property
7 useful for providing potable water to residents of a county.

8 EXPLANATION

9 This bill authorizes counties to issue general obligation
10 bonds to finance the acquisition, construction, or improvement
11 of a water works and water distribution system as an essential
12 county purpose. Essential county purpose bonds are issued
13 after authorization by the board of supervisors with appeal
14 provided to the district court.

15 The bill takes effect July 1 following enactment.
