10 to school population.

11 EXPLANATION

12 This bill changes the names of the state board of public  
13 instruction to the state board of education, the  
14 superintendent of public instruction to the commissioner of  
15 education, and the department of public instruction to the  
16 department of education. It also provides that commencing  
17 with the expiration of the present term of the superintendent,  
18 the commissioner will be appointed by the governor and will  
19 not be required to possess an administrator's endorsement.
