2 amended by adding the following new lettered paragraph:

5292 3 NEW LETTERED PARAGRAPH. i. Organ or tissue transplant  
4 services which are or will be offered in or through an  
5 institutional health facility or a health maintenance  
6 organization at a specific time but which were not offered for  
7 that specific organ or tissue on a regular basis within the  
8 twelve-month period prior to that time.

14 This bill amends the definition of "new institutional  
15 health service" to include organ or tissue transplant services  
16 so that when an institutional health facility or health  
17 maintenance organization would like to provide organ or tissue  
18 transplant services, the service must receive certificate of  
19 need approval.
