1 Section 1. Section 230.10, Code 1987, is amended to read
2 as follows:

3 230.10 PRELIMINARY PAYMENT OF COSTS.

4 All legal costs and expenses attending the taking into
5 custody, care, investigation, and admission or commitment of a
6 person to a state hospital for the mentally ill under a
7 finding that such person has a legal settlement in another
8 county of this state, shall, ~~in the first instance, be paid by~~

13 EXPLANATION

14 This bill prohibits the charging of legal costs and
15 expenses for a commitment or admission of a person into a
16 state hospital for the mentally ill to the county of admission
17 or commitment and requires such charges to be placed against
18 the county of legal settlement after such county is
19 determined.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 230.10, Code 1987, is amended to read as follows:

230.10 PRELIMINARY PAYMENT OF COSTS.

All legal costs and expenses attending the taking into custody, care, investigation, and admission or commitment of a person to a state hospital for the mentally ill under a finding that such person has a legal settlement in another county of this state, ~~shall, in the first instance, be paid by the county of admission or commitment~~ be charged against the county of legal settlement. ~~The county of such legal~~
