AN ACT

RELATING TO THE SALE OF PART OF A GRAVEL PIT OWNED BY A COUNTY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. NEW SECTION. 309.65 SALE OF GRAVEL BED PROPERTY.

Notwithstanding section 309.66, after notice as provided in section 311.305 and a public hearing, the board of supervisors may sell all or part of the property acquired for gravel and other highway improvement materials if the property has been owned by the county for more than five years and the board finds that the property to be sold is not needed for highway
