1 Section 1. Section 157.4, Code 1989, is amended to read as
2 follows:

3 157.4 TEMPORARY PERMITS.

4 Any person who completes the requirements for licensure as
5 a cosmetologist listed in section 157.3, except for the
6 examination, shall be known as a trainee and shall be issued a
7 temporary permit by the department which allows the applicant
8 to practice cosmetology from the date of graduation from the
9 licensed school of cosmetology to the date on which the
10 results of the next succeeding examination for cosmetologists
11 are available. Only one permit shall be issued to a person.
12 However, a trainee who fails the trainee's first attempt to
13 pass the reexamination may be issued a temporary permit or the
14 validity of trainee's temporary permit may be extended to the
15 date on which the results of the next succeeding examination
16 are available. The fee for the temporary permit shall be
17 established by the board as provided in section 147.80.

18 Sec. 2. Section 158.4, Code 1989, is amended to read as
19 follows:

20 158.4 TEMPORARY PERMITS.

21 Any person who completes the requirements for licensure as
22 a barber listed in section 158.3, except for the examination,
23 shall be known as a trainee and shall be issued a temporary
24 permit by the department. The temporary permit allows the
25 applicant to practice barbering from the date of graduation
26 from the licensed barber school to the date on which the
27 results of the next succeeding examination for barbers are
28 available. Only one permit shall be issued to a person.
29 However, a trainee who fails the trainee's first attempt to
30 pass the examination may be issued a temporary permit or the
31 validity of the trainee's permit may be extended to the date
32 on which the results of the next succeeding examination are
33 available. The fee for the temporary permit shall be
34 established by the board as provided in section 147.80.

35 EXPLANATION

1 This bill relates to temporary permits issued to practice
2 cosmetology or barbering. A person who otherwise meets the
3 requirements for licensure as a cosmetologist or a barber, but
4 fails to pass the required examination on the first attempt
5 may be issued a temporary permit to practice or have the
6 validity of an existing permit extended until the results of
7 the next succeeding examination are available.
