14 The bill changes an uncodified provision in the 1990 Iowa  
15 Acts which instructs the department of human services and the

19 clerks of the district court. The schedule was to provide for  
20 completion of the transfer of responsibilities by June 30,  
21 1991. The bill changes this date to June 30, 1993.
