1 An Act providing special motor vehicle license plates for  
2 disabled veterans and providing an effective date.

1 Section 1. Section 321.34, Code 1993, is amended by adding  
2 the following new subsection:

3 NEW SUBSECTION. 13A. DISABLED VETERAN PLATES. The owner  
4 of a motor vehicle subject to registration under section  
5 321.109, subsection 1, light delivery truck, panel delivery  
6 truck, or pickup, who is a disabled veteran, as defined by  
7 section 483A.24, subsection 16, may, upon written application  
8 to the department and sufficient proof that the owner is a  
9 disabled veteran, order special registration plates designed  
10 by the department in cooperation with the adjutant general,  
11 which plates signify that the applicant is a disabled veteran.  
12 The application is subject to approval by the department, in  
13 consultation with the adjutant general, and the special  
14 registration plates shall be issued to the applicant in  
15 exchange for the registration plates previously issued to the  
16 person. An applicant for special plates under this subsection  
17 shall pay a twenty-five dollar fee for issuance of the special  
18 registration plates which shall be in addition to the regular  
19 annual registration fee. The department shall validate the  
20 special plates in the same manner as regular registration  
21 plates are validated under this section with no additional  
22 registration fee being required other than the regular annual  
23 registration fee.

24 Sec. 2. This Act takes effect on January 1, 1994.

25 EXPLANATION

26 This bill provides for the issuance of special motor  
27 vehicle license plates for disabled veterans. Disabled  
28 veteran is defined as provided in section 483A.24, subsection  
29 16, which defines disabled veteran for purposes of a special  
30 fishing and hunting license. A veteran eligible for this  
31 plate shall pay a \$25 fee for the special plates plus any  
32 annual registration fee. This bill is effective January 1,  
33 1994.
